SOUTH AFRICAN CITRUS SCHEME.

**WITHDRAWAL OF LEVY AND SPECIAL LEVY ON LEMONS OTHER THAN LEMONS EXPORTED IN CASES.**

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Citrus Board, referred to in section 2 of the South African Citrus Scheme, published by Proclamation No. 44 of 1947, has, with my approval, withdrawn the provisions, in so far as such provisions relate to lemons, other than lemons exported in cases from the Union, of the following impositions:—

(1) The levy imposed in terms of section 16 of the said scheme, which imposition was published in Government Notice No. 1304 of the 9th June, 1950, as amended by Government Notice No. 1732 of the 1st August, 1952.

(2) The special levy imposed in terms of section 17 of the said scheme, which imposition was published in Government Notice No. 1658 dated 29th June, 1951.

And I do further make known that this withdrawal of the levy impositions specified herein shall become operative upon the date of publication hereof.

**TERUGTREKKING VAN MAKSIMUM PRYSE VAN SUURLEMOENE, EN VAN VERBOD OP VERKOOP.**

Ingevolge artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, STEPHANUS PETRUS LE ROUX, Minister van Landbou, hierby bekend dat die Sitrusraad, genoem in artikel 2 van

the South African Citrus Scheme, published by Proclamation No. 44 of 1947, has with my approval, withdrawn the provisions, insofar as such provisions relate to lemons, of the following prohibitions:—

(1) The prohibitions imposed in terms of section 18 of the said scheme, which prohibitions were published in Government Notice No. 861 of the 24th April, 1953, as amended by Government Notice No. 1149 of the 29th May, 1953.

(2) The prohibitions in terms of section 19 of the said scheme, which prohibitions were published in Government Notice No. 1306 of the 9th June, 1950.

And I do further make known that this withdrawal of the prohibitions specified herein shall become operative upon the date of publication hereof.
