PROHIBITION OF THE PURCHASE OR SALE OF
KAFFIR CORN.

VERBOD OP DIE KOOP OF VERKOOP VAN
KAFFERKORING.

Under the powers vested in me by regulation 3 (4) (a) read in conjunction with regulation 2 (1) (A) of the regulations contained in War Measure No. 55 of 1946 (Government Notice No. 205 of 24th October, 1946), as further continued by War Measures Continuation Acts Nos. 29 of 1950 and 31 of 1952, I, Heinrich Rudolph Philip August Kotzenberg, do hereby prescribe that, with effect from date hereof and until further notice, no person shall acquire any quantity of kaffir corn of the 1954 crop except under permit or other authority in such form as the Director or other person designated by the Director may prescribe, and that no person shall sell or in any other way dispose of any quantity of such kaffir corn except to a person who is in possession of such permit or other authority.

Kragtens die bevoegdheid my verleen by regulasie 3 (4) (a), gelees met regulasie 2 (1) (A) van die regulasies vervat in Oorlogsmaatreël No. 55 van 1946 (Goewermentskennisgewing No. 205 van 24 Oktober 1946), soos verder voortgesit by die Wette op die Voortsetting van Oorlogsmaatreëls Nos. 29 van 1950 en 31 van 1952, skryf ek, Heinrich Rudolph Philip August Kotzenberg, hierby voor dat, met ingang van die datum hiervan en tot nader kennisgewing, niemand enige hoeveelheid kafferking van die 1954-oes mag verkry nie uitgesonderd kragtens 'n permit of ander magtiging in sodanige vorm as wat die Direkteur of ander persoon deur die Direkteur aangewys, voorskryf, en dat niemand enige hoeveelheid sodanige kafferking mag verkoop of op enige ander wyse vervreem nie uitgesonderd aan 'n persoon wat in besit is van so 'n permit of ander magtiging.

Furthermore, in terms of regulation 3 (1) (x) I hereby require that any person other than a producer in possession of kaffir corn of the 1954 season's crop, at date of this notice, shall render to this department, on or before the 30th April, 1954, a return showing details of all such stocks held by him, from whom purchased and at what prices.

Verder vereis ek hierby kragtens regulasie 3 (1) (x) dat enigeen uitgesonderd 'n produsent in besit van kafferking van die 1954-seisoen se oes, op die datum van hierdie kennisgewing, aan hierdie Departement op of voor 30 April 1954 'n opgawe moet verstrek met vermelding van besonderhede van al sodanige voorrade deur hom gehou, van wie dit gekoop is en teen watter pryse.
