NOORD-VRYSTAATSE WATERRAAD, DISTRIK
SASOLBURG, ORANJE-VRYSTAAT—INSTELLING.

NADEMAAL dit wenslik geag word dat 'n gekombineerde skema ingestel word ten einde water vir stedelike, nywerheids- of landboudoeleindes binne die Sasolburgdistrik aan plaaslike besture, enige Staatsdepartement, insluitende die Suid-Afrikaanse Spoorweg- en Hawensadministrasie en 'n provinsiale administrasie, of ander persone te voorsien;

EN NADEMAAL die Staatspresident kragtens sub-artikel (2) van artikel *eenhonderd en agt* van die Waterwet, 1956 (Wet No. 54 van 1956) by proklamasie in die *Staatskoerant* vir die betrokke gebied, soos in die proklamasie omskryf, 'n waterraad kan instel en aan bedoelde raad 'n naam kan toewys;

SO IS DIT DAT EK, kragtens die bevoegdheid my verleen by sub-artikel (2) van artikel *eenhonderd en agt* van genoemde Wet hierby verklaar dat daar met ingang van die datum van publikasie hiervan vir die Sasolburgdistrik, soos omskryf in Goewermenskennisgewing No. 305 van 1957, 'n waterraad is wat as die Noord-Vrystaatse Waterraad bekend staan.

PROCLAMATION.

BY THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH
AFRICA.

NORTHERN FREE STATE WATER BOARD, DIS-
TRICT OF SASOLBURG, ORANGE FREE STATE—
ESTABLISHMENT.

WHEREAS it is deemed desirable that a combined scheme be established for supplying water for urban, industrial or agricultural purposes within the Sasolburg District to local authorities, any department of State, including the South African Railways and Harbours Administration and any provincial administration, or other persons;

AND WHEREAS the State President may, in terms of sub-section (2) of section *one hundred and eight* of the Water Act, 1956 (Act No. 54 of 1956), by proclamation in the *Gazette* establish for the area in question, which shall be defined in the proclamation, a water board and assign a name to such board;

NOW, THEREFORE, under and by virtue of the powers in me vested by sub-section (2) of section *one hundred and eight* of the said Act, I do hereby declare that as from the date of publication hereof there shall be a water board, known as the Northern Free State Water Board, for the Sasolburg District as defined in Government Notice No. 305 of 1957.
