VAN DIE STAATSPRESIDENT VAN DIE REPUBLIEK VAN  
SUID-AFRIKA.

HERAANSTELLING EN AANSTELLING VAN  
SEKERE LEDE VAN DIE SPESIALE HOWE VIR  
DIE VERHOOR VAN INKOMSTE-BELASTING-  
APPËLSAKE.

Nademaal die persone genoem in paragraaf A van die Bylae van hierdie Proklamasie kragtens die bepalings van subartikel 5 (a) van artikel *nege-en-sewentig* van die Inkomstebelastingwet, 1941 (Wet No. 31 van 1941), as lede van die spesiale howe vir die verhoor van inkomstebelastingappëlsake binne die regsgebiede van die Kaapse Provinsiale Afdeling en die Oos-Kaapse Afdeling van die Hooggeregshof EN die gebiede van Natal, die Oranje-Vrystaat en die Transvaal, wat kragtens die bepalings van subartikel (3) van daardie artikel ingestel is, onderskeidelik by Proklamasie No. 307 van 1957 en by Proklamasie No. 145 van 1960 aangestel of heraan gestel was;

En nademaal genoemde lede geag word aangestel te gewees het, en genoemde howe geag word ingestel te gewees het kragtens die bepalings van die Inkomstebelastingwet, 1962 (Wet No. 58 van 1962);

En nademaal die ampstyd van genoemde lede op 8 Augustus 1962 verstryk het;

So is dit dat ek hierby, kragtens die bevoegdheid my verleen by paragraaf (b) van subartikel (5) van artikel *drie-en-tagtig* van die Inkomstebelastingwet, 1962 (Wet No. 58 van 1962), genoemde persone as lede van genoemde spesiale howe vir die verhoor van inkomstebelastingappëlsake vir 'n verdere tydperk van vyf jaar vanaf die datum van hierdie Proklamasie, behoudens die bepalings van die oorbepalings by paragraaf (a) van subartikel (5) van genoemde artikel, heraanstel;

En verder stel ek, ooreenkomstig die bepalings van paragraaf (a) van subartikel (5) van artikel *drie-en-tagtig* van genoemde Wet, as lede van genoemde spesiale howe vir die verhoor van inkomstebelastingappëlsake die persone genoem in paragraaf B van die Bylae van hierdie Proklamasie aan.

PROCLAMATION

BY THE STATE PRESIDENT OF THE REPUBLIC OF  
SOUTH AFRICA.

No. 219, 1962.]

RE-APPOINTMENT AND APPOINTMENT OF  
CERTAIN MEMBERS OF THE SPECIAL  
COURTS FOR HEARING INCOME TAX  
APPEALS.

Whereas by Proclamation No. 307 of 1957 and by Proclamation No. 145 of 1960, the persons mentioned in paragraph A of the Schedule to this Proclamation were appointed or re-appointed under the provisions of sub-section 5 (a) of section *seventy-nine* of the Income Tax Act, 1941 (Act No. 31 of 1941), as members of the special courts for hearing income tax appeals within the areas of jurisdiction of the Cape Provincial Division and the Eastern Cape Division of the Supreme Court AND the areas of Natal, the Orange Free State and the Transvaal, respectively, constituted under the provisions of sub-section (3) of that section;

And whereas the said members are deemed to have been appointed, and the said courts deemed to have been constituted, under the provisions of the Income Tax Act, 1962 (Act No. 58 of 1962);

And whereas the appointments of the said members expired on the 8th August, 1962;

Now, therefore, under the powers vested in me by paragraph (b) of sub-section (5) of section *eighty-three* of the Income Tax Act, 1962 (Act No. 58 of 1962), I do hereby re-appoint the said persons as members of the said special courts for hearing income tax appeals for a further period of five years from the date of this Proclamation, subject to the provisions of the proviso to paragraph (a) of sub-section (5) of the said section;

And further, in terms of the provisions of paragraph (a) of sub-section (5) of section *eighty-three* of the said Act, I do hereby appoint as members of the said special courts for hearing income tax appeals the persons mentioned in paragraph B of the Schedule to this Proclamation.
