



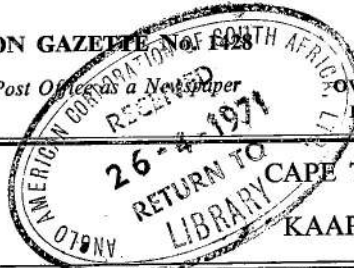

PRICE CONTROL

MAXIMUM PRICES OF CIGARETTES

I, GABRIËL JOSEPH JOHANNES FOURIE STEYN, Price Controller, acting under the powers vested in me by section 4 of the Price Control Act, 1964 (Act 25 of 1964), do hereby prescribe as follows:

1. The maximum prices at which any person may sell cigarettes by retail are the prices at which he ordinarily sold such cigarettes on 30 March 1971 plus one and a half cents per packet of 10 cigarettes, three cents per packet of 20 cigarettes and 5 cents per packet of 30 cigarettes except where on 30 March 1971 he ordinarily sold any such packet at 36 cents, in which case he may add four cents only to that price.
2. This notice applies in the Republic.
3. Government Notice R.848 of 10 May 1968 is hereby withdrawn.

MAKSIMUM PRYSE VAN SIGARETTE

Ek, GABRIËL JOSEPH JOHANNES FOURIE STEYN, Prys-kontroleur, handelende kragtens die bevoegdheid my verleen by artikel 4 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), bepaal hierby soos volg:

1. Die maksimum pryse waarteen iemand sigarette in die kleinhandel mag verkoop, is die pryse waarteen hy sodanige sigarette gewoonlik op 30 Maart 1971 verkoop het plus een en 'n half sent per pakkie van 10 sigarette, drie sent per pakkie van 20 sigarette en 5 sent per pakkie van 30 sigarette behalwe waar hy 'n sodanige pakkie op 30 Maart 1971 gewoonlik teen 'n prys van 36 sent verkoop het in watter geval hy slegs vier sent by daardie prys mag voeg.
2. Hierdie kennisgewing is in die Republiek van toepassing.
3. Goewermentskennisgewing R.848 van 10 Mei 1968 word hierby ingetrek.
