VERKIESING VAN 'N SENATOR

Ek, Jacobus Johannes Fouché, Staatspresident van die Republiek van Suid-Afrika, bepaal hierby ingevolge die bepalings van paragraaf 1 (a) van regulasie 5 van die regulasies vir die verkiesing van senatore in die Republiek van Suid-Afrika, uitgevaardig by Goewermentskennisgewing R. 1341 van 2 September 1960—

(a) Vrydag, 4 April 1975, as die dag waarop 'n sitting van die lede van die Volksraad en van die Provinsiale Raad wat vir die provinsie Natal verkies is, vir die verkiesing van 'n senator gehou moet word;

(b) dat voormelde sitting om 10-uur in die voormiddag van voormelde dag 'n aanvang moet neem; en

(c) dat die Raadsaal van voormelde Provinsiale Raad te Pietermaritzburg die plek is waar voormelde sitting gehou moet word.

PROCLAMATION

by the State President of the Republic of South Africa

No. 73, 1975

ELECTION OF A SENATOR

I, Jacobus Johannes Fouché, State President of the Republic of South Africa, hereby determine in terms of the provisions of paragraph 1 (a) of regulation 5 of the regulations for the election of senators in the Republic of South Africa, issued under Government Notice R. 1341 of 2 September 1960—

(a) that Friday, 4 April 1975, shall be the day on which a sitting of members of the House of Assembly and of the Provincial Council elected for the Province of Natal shall be held for the purpose of the election of a senator;

(b) that the aforesaid sitting shall commence at 10 o'clock in the forenoon of the aforesaid day; and

(c) that the Council Chamber of the said Provincial Council at Pietermaritzburg shall be the place at which the aforesaid sitting shall be held.

Given under my Hand and the Seal of the Republic of South Africa at Cape Town this Seventeenth day of March, One thousand Nine hundred and Seventy-five.
