NATIONAL SUPPLIES PROCUREMENT ACT, 1970
REGULATIONS RELATING TO THE DISPOSAL OR
USE OF MOTOR VEHICLE FUEL

I, Jan Christiaan Heunis, Minister of Economic Affairs, do hereby, in terms of section 2 (b) of the National Supplies Procurement Act, 1970 (Act 89 of 1970), amend Government Notice R. 623 of 11 April 1974, as amended by Government Notice R. 400 of 7 March 1975—

(a) by the substitution for subparagraph (1) of paragraph 2 (1) (b) of the following subparagraphs:

“(1) Between 07h00 to 18h00 from Monday to Friday, both days inclusive;

(1A) between 08h00 to 13h00 on a Saturday; and”;

and
(b) by the substitution for subparagraph (2) of paragraph 4 the following subparagraph:

“(2) No person shall use fuel in a motor vehicle for the purpose of propelling such vehicle along any road at a speed in excess of 90 kilometres per hour”.

REGULASIES MET BETREKKING TOT DIE BESIKKING OOR OF DIE GEBRUIK VAN MOTORVOERTUIGBRANDSTOF

Ek, Jan Christiaan Heunis, Minister van Ekonomiese Sake, wysig hierby, kragtens artikel 2 (b) van die Wet op die Verkryging van Landsvoorrade, 1970 (Wet 89 van 1970), Goewermentskennisgewing R. 623 van 11 April 1974, soos gewysig deur Goewermentskennisgewing R. 400 van 7 Maart 1975—

(a) deur subparagraaf (1) van paragraaf 2 (1) (b) deur die volgende subparagraawe te vervang:

“(1) Tussen 07h00 en 18h00 vanaf Maandag tot en met Vrydag;

(1A) tussen 08h00 en 13h00 op 'n Saterdag; en”;

(b) deur subparagraaf (2) van paragraaf 4 deur die volgende subparagraaf te vervang:

“(2) Niemand mag brandstof in 'n motorvoertuig gebruik met die doel om sodanige voertuig teen 'n snelheid van meer as 90 kilometer per uur op 'n pad aan te dryf nie.”.
