Act No. 5, 1979

SENATE ACT, 1979.

ACT

To extend the period of office of senators.

*(Afrikaans text signed by the State President.)
(Assented to 6 March 1979.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Extension of
period of office
of senators.

1. (1) Notwithstanding anything to the contrary contained in any law but subject to the provisions of section 33 of the Republic of South Africa Constitution Act, 1961 (Act No. 32 of 1961), a person who on the date of commencement of this Act is a senator shall hold his seat until 31 December 1980. 5

(2) Any person who after the date of commencement of this Act becomes a senator on account of the seat of a senator having become vacant on or before that date, shall for the purposes of subsection (1) be deemed to have been a senator on that date. 10

Short title.

2. This Act shall be called the Senate Act, 1979.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. (1) Iemand wat op die datum van inwerkingtreding van hierdie Wet 'n senator is, behou sy setel tot 31 Desember 1980, ondanks andersluidende bepalings van die een of ander wet maar behoudens die bepalings van artikel 33 van die Grondwet van die Republiek van Suid-Afrika, 1961 (Wet No. 32 van 1961). Verlenging van ampstermyn van senatore.

- (2) Iemand wat na die datum van inwerkingtreding van hierdie Wet 'n senator word op grond daarvan dat die setel van 'n senator voor of op daardie datum oopgeval het, word by die toepassing van subartikel (1) geag 'n senator op daardie datum te gewees het.
