The Minister of Statistics has, under section 17 of the Statistics Act, 1976 (Act 66 of 1976), read with Government Notice R. 139 of 4 February 1977 and, in so far as it is applicable in the Territory, with the consent of the Administrator-General, made the regulations in the Schedule hereto in connection with manufacturing.

SCHEDULE**REGULATIONS IN CONNECTION WITH THE CENSUS OF MANUFACTURING, 1979**

(6) gebied, naamlik Blanke gebied, uitgesonderd grensnywerheidsgebied, of grensnywerheidsgebied of Swart staat, waarin die fabriekswese-inrigting geleë is;

(7) eienaarskap, dit wil sê eenmansaak, vennootskap, publieke maatskappy, private maatskappy met beperkte aanspreeklikheid, openbare korporasie, koöperasie, plaaslike owerheidsonderneming, staatsonderneming of ander organisasie;

(8) indien 'n eenmansaak of vennootskap, die bevolkingsgroep van die eienaar(s);

(9) aard van werksaamhede;

(10) of opgawes ten opsigte van die fabriekswese-inrigting moontlik ingedien is vir die Sensus van Mynwese: Finansiële Statistieke; die Sensus van Konstruksie; die Sensus van Groot- en Kleinhandel; of die Sensus van Visserye;

(ii) the slaughtering of livestock, including poultry and small game; and

(iii) installation, assembly, completion, repair and other work;

(b) any premises in which administrative, clerical, sales, research or other activities directly related to any activity referred to in subregulation (a) above are performed.

(2) the "person in charge of a manufacturing establishment" means—

(a) any person who, during the period defined in regulation 3, owned such establishment or any person who was charged by such owner with the supervision or control or the administration, direction or management, as the case may be, of the affairs of such establishment;

(b) any trustee or liquidator or executor or administrator of an insolvent or deceased estate, or a liquidator of a company or a non-profit society or a co-operative society in liquidation, or a judicial manager of a company under judicial management which owned a manufacturing establishment during the period defined in regulation 3.

2. (1) The person in charge of a manufacturing establishment shall, on or before 30 September 1979 or on or before such later date as the Secretary for Statistics may for good cause allow, submit a return or returns in the form of a questionnaire or questionnaires, furnishing all the particulars and information prescribed in regulation 4 hereof, for the period prescribed in regulation 3.

(2) (a) The questionnaire or questionnaires referred to in subregulation (1) above may be obtained from the Secretary for Statistics, Private Bag X44, Pretoria, 0001.

(b) The Secretary for Statistics may send the questionnaire or questionnaires referred to in subregulation (1) above to the person in charge of a manufacturing establishment, but his failure to do so does not exempt any person in charge of such an establishment from the obligation imposed on him by subregulation (1).

3. The period to be covered by the return shall be the financial year of the manufacturing establishment concerned which ended on any date during the period 1 July 1978 up to and including 30 June 1979.

4. The following shall be the matters prescribed in the return required under these regulations:

- (1) Trading name;
- (2) name of proprietor;
- (3) business address;
- (4) address of manufacturing establishment;
- (5) magisterial district in which manufacturing establishment is situated;

(6) area, namely White area, excluding border industrial area, or border industrial area or Black state, in which the manufacturing establishment is situated;

(7) ownership, i.e. individual, partnership, public company, private limited liability company, public corporation, co-operative society, local government undertaking, state enterprise or other organisation;

(8) if individual or partnership, the population group of the owner(s);

(9) nature of activities;

(10) whether returns in respect of the manufacturing establishment have possibly been rendered for the Census of Mining; Financial Statistics; the Census of Construction; the Census of Wholesale and Retail Trade; or the Census of Fishing;

(11) name, adresse en werksaamhede van takinrigtings;

(12) naam, adres en werksaamhede van hoofkantoor of hooftak;

(13) name, adresse en werksaamhede van houer- en filiaalmaatskappye;

(14) besigheids- of boekjaar wat deur die opgawe gedek word;

(15) getal persone in diens (werkende eenaars, met inbegrip van nie-besoldigde familie-assistente en alle besoldigde werknemers volgens aard van werk verrig) ingedeel volgens bevolkingsgroep en geslag;

(16) geraamde netto koste van ondergeskikte dienste en betalings in *natura* vir die boekjaar, ingedeel volgens bevolkingsgroep;

(17) vervaardigings-, handels-, inkomste- en uitgawe-gegewens;

(18) totale uitgawes gedurende die tydperk 1 Julie 1978 tot 30 Junie 1979 aan navorsing en ontwikkeling;

(19) totale uitgawes gedurende die tydperk 1 Julie 1978 tot 30 Junie 1979 aan kopieregte, handelsname en patente;

(20) boekwaarde; kapitaaluitgawes, herwaardering, verkope en oorplasing-uit, verliese deur brand; waardevermindering ingedeel volgens grond; geboue; installasies, masjinerie en ander uitrusting; en voertuie;

(21) boekwaarde van en kapitaaluitgawe aan woongeboue, en nie-woongeboue en konstruksiewerke;

(22) oppervlakte van grond en geboue deur fabriekswese-inrigtings gebruik en benodigde parkeer ruimte;

(23) beskrywing en koste van grondstowwe; verbruiks- en onderhoudsvorrade; materiaal vir kapitaal konstruksie deur eie werknemers; brandstof, lig, krag, stoom en gas; en verpakkingsmateriaal aangekoop en/of oorgeplaas-in;

(24) geraamde koste van grondstowwe ingevoer;

(25) beskrywing, hoeveelheid en waarde van verkope en/of oorplasing-uit van goedere of artikels vervaardig, verwerk, gemaak, voorberei of verpak, en waarde van herstel- en ander werk gedoen;

(26) waarde van uitrusting vervaardig en geboue en werke opgerig deur eie werknemers en gekapitaliseer;

(27) ontleding van verkope volgens tipe klant;

(28) verkope en oorplasing-uit van fabriekswese-inrigtings wat binne 'n Swart staat geleë is.

5. (1) Die persoon in beheer van 'n fabriekswese-inrigting wat sonder redelike oorsaak versuim om aan hierdie Regulasies te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens R200 of, in die geval van voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens R10 vir elke dag waarop sodanige versuim voortduur.

(2) By strafregtelike verrigtinge waarby die persoon in beheer van 'n fabriekswese-inrigting daarvan aangekla word dat hy sonder redelike oorsaak versuim het om aan hierdie Regulasies te voldoen, is dit geen verweer teen die aanklag nie dat daardie persoon geen vraelys of vraelyste ontvang het om die opgawe of opgawes in regulasie 2 omskryf, in te dien nie.

6. Die regulasies afgekondig by Goewermentskennisgewing R. 1729 van 24 September 1976 word hierby herroep.

(11) names, addresses and activities of branch establishments;

(12) name, address and activities of head office or main branch;

(13) names, addresses and activities of holding and subsidiary companies;

(14) business or financial year covered by return;

(15) number of persons employed (working proprietors, including unpaid family assistants and all paid employees, according to nature of work performed) classified according to population group and sex;

(16) estimated net cost of ancillary services and payments in kind for the financial year, classified according to population group;

(17) manufacturing, trading, income and expenditure data;

(18) total expenditure, during the period 1 July 1978 to 30 June 1979, on research and development;

(19) total expenditure, during the period 1 July 1978 to 30 June 1979, on copyrights, trade names and patents;

(20) book value; capital expenditure; revaluation; sales and transfers-out; losses by fire; depreciation classified to land; buildings; plant, machinery and other equipment; and vehicles;

(21) book value of and capital expenditure on residential buildings, non-residential buildings and construction works;

(22) area of land and buildings used by manufacturing establishments and required parking space;

(23) description and cost of raw materials; consumable and maintenance stores; materials for capital construction by own employees; fuel, light, power, steam and gas; and packing materials, purchased and/or transferred-in;

(24) estimated cost of imported raw materials;

(25) description, quantity and value of sales and/or transfers-out of goods or commodities manufactured, processed, made, prepared or packed, and value of repair and other work done;

(26) value of equipment manufactured and buildings and works erected by own employees and capitalised;

(27) analysis of sales according to class of customer; and

(28) sales and transfers-out of manufacturing establishments situated in a Black state.

5. (1) Any person in charge of a manufacturing establishment who, without reasonable cause, fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding R200 or, in the case of a continuing failure to comply therewith, to a fine not exceeding R10 for every day during which such failure continues.

(2) At criminal proceedings where any person in charge of a manufacturing establishment is accused that he, without reasonable cause, failed to comply with these regulations, it will be no defence against the accusation that such person did not receive a questionnaire or questionnaires to submit the return or returns as defined in regulation 2.

6. The regulations published in Government Notice R. 1729 of 24 September 1976, are hereby repealed.

Note.—The Secretary for Statistics may compile a name and address list of manufacturing establishments, classified according to activities, and furnish it to any person or organisation.
