**KANGWANE.—VERKLARING TOT SELF-
 REGERENDE GEBIED**

Nademaal dit dienstig geag word dat die gebied waarvoor die KaNgwane- Wetgewende Vergadering by Proklamasie R. 214 van 16 September 1977 ingestel is, onder die naam KaNgwane 'n selfregerende gebied binne die Republiek moet wees ooreenkomstig die bepalings van die Grondwet van die Nasionale State, 1971 (Wet 21 van 1971);

En nademaal genoemde KaNgwane- Wetgewende Vergadering behoorlik geraadpleeg is deur die Minister van Samewerking en Ontwikkeling soos bepaal by artikel 26 (1) van genoemde Wet;

En nademaal dit dienstig geag word om SiSwati as 'n addisionele amptelike taal van die gebied vir sekere doeleindes te erken;

So is dit dat ek kragtens die bevoegdheid my verleen by artikel 26 van die Grondwet van die Nasionale State, 1971 (Wet 21 van 1971), en artikel 108 van die Grondwet van die Republiek van Suid-Afrika, 1961 (Wet 32 van 1961), hierby soos volg verklaar:

KANGWANE WORD 'N SELFREGERENDE GEBIED

1. Die gebied beskryf in Bylae I van Proklamasie R. 214 van 1977 is met ingang van 31 Augustus 1984 onder die naam KaNgwane 'n selfregerende gebied binne die Republiek van Suid-Afrika in ooreenstemming met die bepalings van die Grondwet van die Nasionale State, 1971 (Wet 21 van 1971).

ADDISIONELE AMPTELIKE TAAL

2. Die SiSwati-taal word erken—

(a) as addisionele amptelike taal van KaNgwane; en

(b) vir gebruik in KaNgwane vir die amptelike doeleindes wat by Proklamasie R. 214 van 1977 voorgeskryf word en kan buite genoemde gebied gebruik word vir sodanige doeleindes rakende die sake van die gebied.

**KANGWANE.—DECLARATION AS A SELF-
 GOVERNING TERRITORY**

Whereas it is deemed expedient that the area for which the KaNgwane Legislative Assembly has been established under Proclamation R. 214, dated 16 September 1977, shall under the name of KaNgwane be a self-governing territory within the Republic in accordance with the provisions of the National States Constitution Act, 1971 (Act 21 of 1971);

And whereas the said KaNgwane Legislative Assembly has been duly consulted by the Minister of Co-operation and Development as provided in section 26 (1) of the said Act;

And whereas it is deemed expedient to recognize SiSwati as an additional official language of the territory for certain purposes;

Now, therefore, under and by virtue of the powers vested in me by section 26 of the National States Constitution Act, 1971 (Act 21 of 1971), and section 108 of the Republic of South Africa Constitution Act, 1961 (Act 32 of 1961), I hereby declare as follows:

**KANGWANE TO BE A SELF-GOVERNING
 TERRITORY**

1. The area described in Schedule I to Proclamation R. 214 of 1977 shall under the name of KaNgwane be a self-governing territory within the Republic of South Africa in accordance with the provisions of the National States Constitution Act, 1971 (Act 21 of 1971), with effect from 31 August 1984.

ADDITIONAL OFFICIAL LANGUAGE

2. The SiSwati language shall be recognized—

(a) as an additional official language of KaNgwane; and

(b) for use in KaNgwane for the official purposes prescribed by Proclamation R. 214 of 1977, and may be used outside the said territory for such purposes connected with the affairs of the territory.

Kragtens die bevoegheid my verleen by artikel 25 (1) van die Swart Administrasie Wet, 1927 (Wet 38 van 1927)—

(1) verklaar ek hierby dat, met ingang van 31 Augustus 1984, 'n verwysing in Proklamasies R. 214, R. 216, R. 217, R. 218 en R. 219 van 1977 en R. 2409 van 1978, soos gewysig—

(2) herroep ek hierby Proklamasie R. 215 van 1977 in sy geheel met ingang van 31 Augustus 1984.

KANGWANE.—INTERPRETATION OF CERTAIN EXPRESSIONS IN PROCLAMATIONS R. 214, R. 216, R. 217, R. 218 AND R. 219 OF 1977, R. 2409 OF 1978, AS AMENDED, AND REPEAL OF PROCLAMATION R. 215 OF 1977

Under and by virtue of the powers vested in me by section 25 (1) of the Black Administration Act, 1927 (Act 38 of 1927)—

(1) I hereby declare that, with effect from 31 August 1984, any reference in Proclamations R. 214, R. 216, R. 217, R. 218 and R. 219 of 1977, and R. 2409 of 1978, as amended—

(a) to the Executive Council, the Chief Executive Councillor and an Executive Councillor shall be construed as a reference to the Cabinet, the Chief Minister and a Minister respectively; and

(b) to the Director of a department of the KaNgwane Government shall be construed as a reference to the Secretary for such department;

(2) I hereby repeal Proclamation R. 215 of 1977 in its entirety with effect from 31 August 1984.
