VALIDATION OF CERTAIN EXPENDITURE ACT, 1987

ACT

To validate the expenditure from the Ciskeian Revenue Fund of certain moneys.

(English text signed by the President. Assented to on 4 August 1987).

BE IT ENACTED by the National Assembly of the Republic of Ciskei, as follows:-

1. Validation of certain expenditure. - The expenditure from the funds of the Ciskeian Revenue Fund, on the expenditure related to or arising from the matters mentioned in the Schedule, in the amount of four million three hundred and ninety-three thousand one hundred and ninety-eight rand (R4 393 198) during the period 1 August 1972 to the date of this enactment, is hereby validated.

2. Short title. - This Act shall be called the Validation of Certain Expenditure Act, 1987.

SCHEDULE

1. Vote 3, 12, 15, 21 and 22: Department of Public Works: R1 332 212 - Expenditure incurred on or in relation to any residence, farm or other place owned or occupied by the Head of State for the purpose of or relating to —

- (a) the provision of suitable accommodation, furnishings and amenities commensurate with the needs of the occupants, as well as of distinguished guests and visitors more especially from overseas; and
- (b) ensuring the safety and security of such occupants and visitors.

2. Vote 5, 16, 18, 19 and 20: Department of Agriculture and Forestry: R2 135 369 - Expenditure incurred on or in connection with any land, buildings or structures owned or occupied by the Head of State or any equipment or services used or relating thereto —

- (a) for the purpose of alterations, additions, erection, conversion, construction, extension, maintenance or upgrading of any land, building or other structure thereon;
- (b) for general farming or for experimental or other like purposes intended to further or demonstrate methods and practices relating to the beneficial use of such land, including the remuneration of persons employed in connection therewith.

3. Vote 3, 12, 15, 21 and 22: Department of Public Works and Vote 5, 16, 18, 19 and 20: Department of Agriculture and Forestry : R925 617 - Expenditure incurred on or in connection with any land, buildings or structures owned or occupied by the Head of State or relating to any machinery, tools, equipment or amenities used on or in connection therewith or any charges, professional services and reports in connection therewith.
