APPROPRIATION ACT (HOUSE OF REPRESENTATIVES), 1987

ACT

To appropriate amounts of money for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1988.

(English text signed by the State President.)
(Assented to 25 August 1987.)

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

Appropriation of amounts of money for requirements of Administration: House of Representatives.

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1988, the amounts of money shown in column 1 of the Schedule, with which the Revenue Account: House of Representatives shall be charged. 5

Short title.

2. This Act shall be called the Appropriation Act (House of 10 Representatives), 1987.
