- (i) Proklamasie 1 van 1904 en Bylae A van Goewermentskennisgewing 1896 van 1983 wysig deur die plaaslike grense van die distrik Bloemfontein uit te brei deur die insluiting van die gebied soos omskryf in Bylae A, met uitsluiting van die gebied soos omskryf in Bylae B.
- (ii) Goewermentskennisgewing 1883 van 1983 intrek.

BYLAE A

Begin by die noordwestelike baken van die plaas Thipa 400, administratiewe distrik Thaba Nchu; daarvandaan ooswaarts en algemeen suidwaarts met die grense van die volgende plase sodat dit by hierdie gebied ingesluit word: Thipa 400, Boichoko 6, Zonderhout 439, Zonderhout "A" 468, Israel'spoort 14, Sebata 134, Bonolo 52, Lesaka 81, Onverwacht 704, Spitzpunt 385, Zamenloop 56, Restant van Greylings Rust 242 en Gelukszuiping 243, tot by die suidelike baken van laasgenoemde plaas; daarvandaan algemeen noordweswaarts en noordwaarts met die grense van die volgende plase langs sodat dit by hierdie gebied ingesluit word: Gelukszuiping 243, Mariasrus 809, Spes Bona 384, Ramah 473, Travalgar 2, Ramahutshe 47, Justice 478 en Thipa 400, almal in die administratiewe distrik Thaba Nchu, tot by die beginpunt.

BYLAE B

Begin by die punt waar die suidelike padreserwegrens van die Bloemfontein—Thaba Nchu-teerpad die westelike grens van die grens van die plaas Kalverhok 562 kruis; daarvandaan algemeen suidwaarts en suidweswaarts en noordweswaarts met die grense van die volgende eiendomme

ALTERATION OF THE LOCAL LIMITS OF THE DISTRICT OF BLOEMFONTEIN

By virtue of the powers vested in me by section 2 (1) (c) and (1) of the Magistrates' Courts Act, 1944 (Act 32 of 1944), I, Hendrik Jacobus Coetsee, Minister of Justice, hereby:

- (i) Amend Proclamation 1 of 1904 and Schedule A of Government Notice 1896 of 1983 by increasing the local limits of the District of Bloemfontein by the inclusion of the area as defined in Schedule A with the exclusion of the area as defined in Schedule B.
- (ii) Withdraw Government Notice 1883 of 1983.

SCHEDULE A

Beginning at the northwestern beacon of the farm Thipa 400, Administrative District of Thaba Nchu; thence eastwards and generally southwards along the boundaries of the following farms, so as to include them in this area: Thipa 400, Boichoko 6, Zonderhout 439, Zonderhout "A" 468, Israel'spoort 14, Sebata 134, Bonolo 52, Lesaka 81, Onverwacht 704, Spitzpunt 385, Zamenloop 56, Remainder of Greylings Rust 242 and Gelukszuiping 243, to the southern beacon of the last-named farm; thence generally northwards and northwards along the boundaries of the following farms, so as to include them in this area: Gelukszuiping 243, Mariasrus 809, Spes Bona 384, Ramah 473, Travalgar 2, Ramahutshe 47, Justice 478 and Thipa 400, all in the Administrative District of Thaba Nchu, to the point of beginning.

SCHEDULE B

Beginning at the point where the southern road reserve boundary of the Bloemfontein—Thaba Nchu tarred road intersects the western boundary of the farm Kalverhok 562, thence generally southwards and southwestwards and northwards along the boundaries of the following properties

so as to include them in this area: The farms Bonolo 52, Lesaka 81, Onverwacht 704, Spitzpunt 385 and Zamenloop 56, the remaining extent of the farm Greylings Rust 242, and the farms Gelukszuiping 243, Mariasrus 809, Mooiplaats 772, Spes Bona 394 and Ramah 473 to the northwestern beacon of the said Ramah 473, thence in a straight line in the direction of the southwestern beacon of the farm Justice 478 up to the point where this line intersects the southern road reserve boundary of the Bloemfontein—Thaba Nchu tarred road; thence generally eastwards along the southern road reserve boundary of the Bloemfontein—Thaba Nchu road to where the said boundary intersects the western boundary of the farm Kalverhok 562, the point of beginning.
