- (2) hulde gebring word aan GOVAN ARCHIBALD MBEKI; of
- (3) die vrylating van GOVAN ARCHIBALD MBEKI uit aanhouding herdenk of gevier word.

ORDER UNDER THE REGULATIONS MADE UNDER
THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by regulation 7 (1) (c) of the regulations published under the Public Safety Act, 1953 (Act 3 of 1953), by Proclamation R. 96 of 11 June 1987, as amended by Proclamation R. 106 of 26 June 1987, I, ROELOF PETRUS JANSEN VAN VUUREN, Acting Commissioner of the South African Police, hereby prohibit, in the Magisterial Districts of Johannesburg and Roodepoort, during the period ending on 18 January 1988, any gathering at which—

- (1) the seventy-sixth year of existence of the AFRICAN NATIONAL CONGRESS is commemorated or celebrated; or
- (2) homage is paid to GOVAN ARCHIBALD MBEKI; or
- (3) the release from detention of GOVAN ARCHIBALD MBEKI is commemorated or celebrated.
