CO-OPERATIVES ACT, 1981 (ACT 91 OF 1981)

COMPULSORY SALE OF OSTRICHES AND OSTRICH  
PRODUCTS THROUGH KLEIN KAROO AGRICUL-  
TURAL CO-OPERATIVE LIMITED

I, Jacob Johannes Greyling Wentzel, Minister of Agricul-  
ture, acting under section 241 of the Co-operatives Act,  
1981 (Act 91 of 1981), hereby—

(a) at the request of Klein Karoo Agricultural Co-  
operative Limited, make the provisions set out in the  
Schedule; and

(b) determine that the said provisions shall come into  
operation on the date of publication hereof; and

(c) repeal Government Notices 640 of 9 May 1958,  
1166 of 31 July 1959 and 875 of 5 June 1970.

#### SCHEDULE

#### Definitions

1. Any word or expression in this Schedule to which a  
meaning has been assigned in the Act shall have that mean-  
ing and, unless the context otherwise indicates—

“exempted area” means the Magisterial Districts of  
Calitzdorp, Ladismith, Oudtshoorn, Prince Albert,  
Uniondale and Willowmore, and that portion of the  
Magisterial District of George situate north of the Outeni-  
qua Mountains;

“producer” includes—

(a) any person concerned in the production of  
ostriches or ostrich products; and

(b) met betrekking tot 'n hoeveelheid volstruise of volstruisprodukte wat van iemand verkry is as vergoeding vir die reg om grond te gebruik waarop daardie persoon 'n hoeveelheid volstruise of volstruisprodukte geproduseer het, of as beloning vir dienste aan 'n produsent van volstruise of volstruisprodukte gelewer, die persoon wat daardie hoeveelheid aldus verkry het;

“volstruisprodukte” enigiets verkry van volstruise, hetsy verwerk al dan nie, maar nie ook volstruiseierdoppe nie; en

“vrygestelde gebied” die landdrostdistrikte van Calitzdorp, Ladismith, Oudtshoorn, Prins Albert, Uniondale en Willowmore, en daardie gedeelte van die landdrostdistrik George wat noord van die Outeniekwa-berge geleë is.

#### **Beperking op die verkoop van volstruise en volstruisprodukte**

2. (1) Geen produsent in die Republiek mag enige volstruise of volstruisprodukte anders verkoop of anders van die hand sit nie dan behalwe deur tussenkoms van die Koöperasie.

(2) Die bepaling van subklousule (1) is nie van toepassing nie op—

(a) die verkoop of van-die-handsetting van volstruise en volstruiseiers deur 'n produsent aan 'n produsent in die vrygestelde gebied; en

(b) die verkoop of van-die-handsetting van volstruisprodukte deur 'n produsent indien daardie volstruisprodukte reeds een maal in enige vorm hoegenaamd deur tussenkoms van die Koöperasie verkoop of anders van die hand gesit is.

(b) in relation to any quantity of ostriches or ostrich products that have been acquired from any person as a consideration for the right to use land on which that person has produced a quantity of ostriches or ostrich products, or as remuneration for services rendered to a producer of ostriches or ostrich products, the person who so acquired that quantity;

“ostrich products” means anything derived from ostriches, whether processed or not, but not also ostrich-egg shells;

“the Act” means the Co-operatives Act, 1981 (Act 91 of 1981), as amended; and

“the Co-operative” means Klein Karoo Agricultural Co-operative Limited.

#### **Restriction on the sale of ostriches and ostrich products**

2. (1) No producer in the Republic shall sell or otherwise dispose of any ostriches or ostrich products otherwise than through the Co-operative.

(2) The provisions of subclause (1) shall not apply to—

(a) the sale or disposal of ostriches and ostrich eggs by a producer to any producer in the exempted area; and

(b) the sale or disposal of ostrich products by a producer if those ostrich products have already been sold or otherwise disposed of once in any form whatsoever through the Co-operative.
