**DEPOSIT-TAKING INSTITUTIONS ACT, 1990****CALL LOANS WHICH RANK AS LIQUID ASSETS.—  
DESIGNATION OF DEPOSIT-TAKING INSTITU-  
TIONS CONCERNED**

Under paragraph (c) of the definition of "liquid assets" in section 1 (1) of the Deposit-taking Institutions Act, 1990 (Act No. 94 of 1990), I, Barend Jacobus du Plessis, Minister of Finance, hereby designate, for the period terminating on 31 January 1993, the deposit-taking institutions described in the Schedule as deposit-taking institutions of whom the loans, repayable on demand, taken up by them shall rank as liquid assets for the purposes of the said Act.

**SCHEDULE**

Deposit-taking institutions which offer the facility of the taking up of short-term funds of other deposit-taking institutions and which first-mentioned deposit-taking institutions were immediately prior to the date of commencement of the Deposit-taking Institutions Act, 1990, registered as discount houses in the terms of the Banks Act, 1965 (Act No. 23 of 1965).
