ACT

To amend the Land Use Planning Ordinance, 1985 (Cape) (in so far as it is applied as a law on own affairs of the White population group), so as to empower a council to levy fees at such tariffs as the Minister may approve in respect of applications; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Definition

1. In this Act, unless the context otherwise indicates, “the Ordinance” means the Land Use Planning Ordinance, 1985 (Ordinance No. 15 of 1985) (Cape), in so far as and to the extent to which the provisions of Part IV of the Republic of South Africa Constitution Act, 1983 (Act No. 110 of 1983), have by paragraph (a) of Proclamation No. R. 37 of 1989 been declared to apply to the said Ordinance. 5

Amendment of section 38 of Ordinance 15 of 1985, as amended by paragraph 2 of Proclamation 100 of 1987 (Cape) 10

2. Section 38 of the Ordinance is hereby amended by the substitution for subsection (3) of the following subsection:

“(3) Notwithstanding the provisions of any other law **[no fees, other than for expenditure actually incurred in connection with the advertising of an application, shall be levied]** a council may levy fees at such tariffs as the Minister may approve in respect of any application contemplated by subsection (1).” 15

Short title and commencement

3. This Act shall be called the Land Use Planning Ordinance Amendment Act (Cape) (House of Assembly), 1991, and shall come into operation on a date fixed by the State President by proclamation in the *Gazette*. 20
