No. 133 of 1991: Pensions (Supplementary) Act, 1991

ACT

To provide for the award of certain pension benefits.

(English text signed by the State President.)
(Assented to 27 June 1991.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Award of certain pension benefits

1. There shall be paid to the person mentioned in the Schedule the pension benefits mentioned therein. 5

Short title

2. This Act shall be called the Pensions (Supplementary) Act, 1991.

Schedule

For the purposes of the Military Pensions Act, 1976 (Act No. 84 of 1976), it shall be deemed that P J du Toit, formerly a school cadet, was a member of the South African Defence Force on 3 December 1983 and that he shall therefore be entitled to an applicable pension or gratuity in terms of the said Act with effect from 1 October 1989. 10

By die toepassing van die Wet op Militêre Pensioene, 1976 (Wet No. 84 van 10 1976), word geag dat P J du Toit, voorheen 'n skoolkadet, op 3 Desember 1983 'n lid van die Suid-Afrikaanse Weermag was en dat hy derhalwe met ingang van 1 Oktober 1989 op 'n toepaslike pensioen of gratifikasie ingevolge genoemde Wet geregtig is.
