WITHDRAWAL OF NOTICE UNDER THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 5A of the Public Safety Act, 1953 (Act No. 3 of 1953), I, Adriaan Johannes Vlok, Minister of Law and Order hereby withdraw, with effect from 12 August 1991, Government Notice No. R. 1243 of 25 May 1991, whereby the Magisterial District of Vanderbijlpark, including the areas known as Sebokeng and Evaton, was declared to be an unrest area.
