#### ANNEXURE

For general information it is hereby notified that the State President has, under the powers vested in him by section 35 (1) of the Public Service Act, 1984 (Act No. 111 of 1984), made the following regulations:

The Public Service Regulations, published under Government Notice No. 2047 of 11 December 1959, as amended, are hereby further amended by—

- (a) adding the words "in the Republic" to the headings of regulations F4.8 (a) (i) and (ii);
- (b) inserting the following subparagraph (iii) after regulation F4.8 (a) (ii) (bb):

“(iii) *An officer or employee who is transferred to or in a foreign country*

An amount equal to 35% of the monthly norm station allowance in the local monetary unit concerned as on the date of resettlement.”

- (c) inserting the numbers "(i) or (ii)" after the words "subparagraph (a)" in regulations F4.8 (b) and (c).

Die Staatsdiensregulasies gepubliseer by Goewermenskennisgewing No. 2047 van 11 Desember 1959, soos gewysig, word hierby verder gewysig deur—

- (a) in die opskrifte van regulasies F4.8 (a) (i) en (ii) die woorde "in die Republiek" in te voeg na die woord "huisvesting";
- (b) na regulasie F4.8 (a) (ii) (bb) die volgende subparagraaf (iii) in te voeg:

“(iii) *'n Beampte of werknemer wat na of in die buiteland oorgeplaas word*

'n Bedrag gelyk aan 35% van die maandelikse normstandplaastoelae in die betrokke plaaslike munteenheid soos op die datum van hervestiging.”

- (c) in regulasies F4.8 (b) en (c) na die woorde "subparagraaf (a)" die nommers "(i) of (ii)" in te voeg.
