

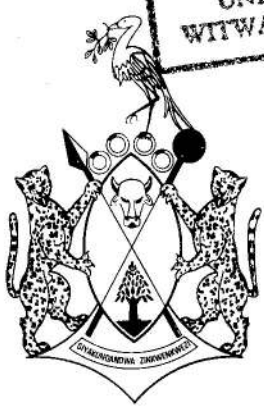

It is hereby notified that the Chairman of the Council of State has assented to the following decree which is hereby published for general information: -

COUNCIL OF STATE — REPUBLIC OF CISKEI

INDEMNITY THIRD AMENDMENT DECREE, 1991

DECREE

To amend further the Indemnity Decree, 1990.

[English text signed by the Chairman of the Council of State. Assented to on 30 October 1991.]

BE IT DECREED by the Council of State of the Republic of Ciskei as follows:-

1. (1) Substitution of section 1 of Decree 11 of 1990, as amended by section 1 of Decree 2 of 1991. - The following section is hereby substituted for section 1 of the Indemnity Decree, 1990:

"1. Indemnity. - No proceedings, whether civil or criminal, shall be instituted or continued in any court of law against -

- (a) the Republic of Ciskei or the Government thereof, or
- (b) the Council of State or the Chairman or Deputy Chairman or other member thereof, or
- (c) any Minister or department of State, or
- (d) any officer or other member of the Defence Force, or
- (e) any officer or other member of the Ciskeian Police, or
- (f) any other person in the service of the State, or
- (g) any person acting under the authority, or by direction, or with the approval, of the holder of any office or other person referred to in paragraph (b), (c), (d), (e), or (f).

by reason of any act advised, commanded, ordered or directed or performed or done at any time on or after the date of commencement of this decree in respect of or in relation to -

- (i) the assumption and exercise of power in and over the Republic of Ciskei;
- (ii) the effective control of the continued administration of the said Republic;
- (iii) the maintenance of peace, order and good government;
- (iv) the prevention, suppression or termination of internal disorder and the restoration and enforcement of public safety; and
- (v) the protection and preservation of life and property and the continuation and maintenance of essential services."

(2) Subsection (1) shall for the purposes of section 22 of the Republic of Ciskei Constitution Decree, 1990 (Decree 45 of 1990) be deemed to be such a restriction as is contemplated in subsection (5) of that section.

2. Short title. - This decree shall be called the Indemnity Third Amendment Decree, 1991.
