#### REGULATIONS REGARDING THE PAYMENT OF ANNUAL FEES: AMENDMENT

The Deputy Minister of Law and Order, acting on behalf of and on assignment by the Minister of Law and Order has, after consultation with the Security Officers' Board, under section 32 (1) of the Security Officers Act, 1987 (Act No. 92 of 1987), made the regulations in the Schedule.

#### SCHEDULE

##### Definition

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R. 797 of 2 April 1990.

##### Amendment of regulation 8 of the Regulations

2. Regulation 8 of the Regulations is hereby amended—

(a) by the substitution for subregulation (2) of the following subregulation:

"(2) Subject to subregulation (3), the prescribed fees mentioned in subregulation (1) shall be paid within three months of the said date on which the name was entered."; and

(b) by the addition of the following subregulation:

"(3) A security officer whose name has on or after 1 January 1991 been entered in the register, but who has on the date of coming into operation of this subregulation not paid the prescribed fees mentioned in subregulation (1), shall pay such fees in respect of the year 1991 before 1 October 1991."

#### REGULASIES BETREFFENDE DIE BETALING VAN JAARGELDE: WYSIGING

Die Adjunkminister van Wet en Orde, handelende namens en in opdrag van die Minister van Wet en Orde, het na oorlegpleging met die Raad vir Sekuriteitsbeamptes, kragtens artikel 32 (1) van die Wet op Sekuriteitsbeamptes, 1987 (Wet No. 92 van 1987), die regulasies in die Bylae uitgevaardig.

#### BYLAE

##### Woordomskrywing

1. In hierdie regulasies beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing No. R. 797 van 2 April 1990.

##### Wysiging van regulasie 8 van die Regulasies

2. Regulasie 8 van die Regulasies word hierby gewysig—

(a) deur subregulasie (2) deur die volgende subregulasie te vervang:

"(2) Behoudens subregulasie (3), moet die voorgeskrewe gelde bedoel in subregulasie (1) binne drie maande na bedoelde datum waarop die naam ingeskryf word, betaal word."; en

(b) deur die volgende subregulasie by te voeg:

"(3) 'n Sekuriteitsbeampte wie se naam op of na 1 Januarie 1991 in die register ingeskryf is, maar wat op die datum van inwerkingtreding van hierdie subregulasie nog nie die voorgeskrewe gelde bedoel in subregulasie (1) betaal het nie, moet sodanige gelde ten opsigte van die jaar 1991 voor 1 Oktober 1991 betaal."
