INCREASE OF BENEFITS

I, Pieter Gabriel Marais, Minister of Manpower, authorise, by virtue of the powers vested in me by sections 38, 39, 40 and 43(bis) of the Workmen's Compensation Act, 1941 (Act No. 30 of 1941), hereby—

- (a) (i) for the purposes of paragraph (a) of subsection (1) of section 38 of the Act, the substitution for the expression "R2 500" of the expression "R3 000";
- (ii) for the purposes of subsection (4) of section 38 of the Act, the substitution for the expression "R2 500" of the expression "R3 000";
- (b) (i) for the purposes of paragraph (a) of subsection (1) of section 39 of the Act, the substitution for the expression "R1 400" of the expression "R1 680";
- (ii) for the purposes of paragraph (c) of subsection (1) of section 39 of the Act, the substitution for the expression "R2 500" of the expression "R3 000";
- (iii) for the purposes of subsection (2) of section 39 of the Act, the substitution for the expression "R2 500" of the expression "R3 000";
- (c) (i) for the purposes of paragraph (a) of subsection (1) of section 40 of the Act, the substitution for the expression "R1 875" of the expression "R2 250";
- (ii) for the purposes of subsection (2) of section 40 of the Act, the substitution for the expression "R2 000" of the expression "R2 600";

(d) vir die doeleindes van artikel 43(bis) van die Wet, 'n verhoging van—

- (i) 6% in alle maandelikse pensioene wat toegeken is ten opsigte van ongevallen wat voor 1 Maart 1991 plaasgevind het;
