- 5 **1.** Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1992, as a charge to the Revenue Account: House of Assembly, the additional amounts of money shown in column 1 of the Schedule.
