Tot wysiging van die Multilaterale Motorvoertuigongelukkefondswet, 1989, ten einde voorsiening te maak vir die maandelikse storting van geld in die Multilaterale Motorvoertuigongelukkefonds; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Vervanging van artikel 5 van Wet 93 van 1989

1. Artikel 5 van die Multilaterale Motorvoertuigongelukkefondswet, 1989, word hierby deur die volgende artikel vervang: 5

“Geld in MMF

5. In die MMF word **[kwartaalsgewys]** maandeliks gestort al die geld wat, as dit nie vir die bepalings van artikel 3 van hierdie Wet was nie, die Motorvoertuigongelukkefonds in paragraaf (b) van genoemde artikel 3 genoem uit hoofde van die bepalings van artikel 10 1(2)(a)(ii) van die Wet op die Sentrale Energiefonds, 1977 (Wet No. 38 van 1977), sou ontvang, bereken vir die laaste **[kwartaal]** maand waarvoor sodanige som bereken kan word.”.

Kort titel en inwerkingtreding

2. Hierdie Wet heet die Wysigingswet op die Multilaterale Motorvoertuigongelukkefondswet, 1992, en tree op 1 Mei 1992 in werking. 15

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Substitution of section 5 of Act 93 of 1989

1. The following section is hereby substituted for section 5 of the Multilateral Motor Vehicle Accidents Fund Act, 1989:

“Moneys in MMF

10 5. There shall be paid into the MMF **[quarterly]** monthly all moneys which would, but for the provisions of section 3 of this Act, be received by the Motor Vehicle Accident Fund mentioned in paragraph (b) of the said section 3 by virtue of the provisions of section 1(2)(a)(ii) of the Central Energy Fund Act, 1977 (Act No. 38 of 1977), for the latest **[quarter]** month for which such sum can be calculated.”.

Short title and commencement

15 2. This Act shall be called the Multilateral Motor Vehicle Accidents Fund Amendment Act, 1992, and shall come into operation on 1 May 1992.

"Moneys in MME

2. There shall be paid into the MME [quarterly] monthly all moneys which would, but for the provisions of section 3 of this Act, be received by the Motor Vehicle Accident Fund mentioned in paragraph (b) of the said section 3 by virtue of the provisions of section 4(2)(a)(ii) of the Central Energy Fund Act, 1977 (Act No. 38 of 1977), for the latest [quarter] month for which such sum can be calculated."

Short title and commencement

3. This Act shall be called the Multilateral Motor Vehicle Accidents Fund Amendment Act, 1992, and shall come into operation on 1 May 1992.
