Kragtens die bevoegdheid my verleen by artikel 55 (1) van die Boswet, 1984 (Wet 122 van 1984), wysig ek, Magnus André de Merindol Malan, Minister van Waterwese en Bosbou hierby die Bylae by Kennisgewing 577 van 31 Maart 1988 in die mate in die Bylae hierby uiteengesit.

BYLAE

1. Deur die woorde "dertig komma agt (30,8) sent" in paragraaf 2.2.1.1 met ingang van 1 April 1992 deur die woorde "twee-en-dertig komma nul vyf (32,05) sent", te vervang.

2. Deur bykomende paragraaf 2.2.1.2 met ingang van 1 Maart 1992 in te voeg om te lees:

"Elke houtkweker, met die uitsondering van die Staat en alle geregistreerde lede van Forest Owners' Association betaal 'n addisionele heffing van 4,7c per m³ in die ronde maat wat deur hom van die hand gesit word waarvan die totale inkomste uit hierdie heffing betaalbaar is aan die Suid-Afrikaanse Houtkwekersvereniging. Hierdie heffing word ingevorder soos in paragraaf 5 voorgeskryf."

AMENDMENT OF LEVY ON TIMBER AND IMPORTED TIMBER DERIVATIVES

By virtue of the powers vested in me by section 55 (1) of the Forest Act, 1984 (Act 122 of 1984), I, Magnus André de Merindol Malan, Minister of Water Affairs and Forestry, hereby amend the Annexure to Notice 577 of 31 March 1988 to the extent as set out in the Annexure hereto.

ANNEXURE

1. By the substitution with effect from 1 April 1992 for the words "thirty comma eight (30,8) cents" in paragraph 2.2.1.1 of the words "thirty two comma nought five (32,05) cents."

2. By the insertion with effect from 1 March 1992 additional paragraph 2.2.1.2 to read:

"Each timber grower, with the exception of the State and all registered members of the Forest Owners' Association, shall pay an additional levy of 4,7c per m³ of timber in the round disposed of by him, the entire proceeds of which levy shall be payable to the South African Timber Growers' Association. This levy shall be collected as prescribed in paragraph 5."
