It is hereby notified that the Chairman of the Council of State has assented to the following decree which is hereby published for general information: -

COUNCIL OF STATE — REPUBLIC OF CISKEI

SECURITY AMENDMENT DECREE, 1992

DECREE

To amend the National Security Act, 1982 and to provide for incidental matters.

[English text signed by the Chairman of the Council of State. Assented to on 6 July 1992].

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows: -

1. Substitution of section 92 of Act 13 of 1982. - The following section is hereby substituted for section 92 of the National Security Act, 1982: -

"92. Deputy Chairman may take any steps the Chairman may take. - The Deputy Chairman of the Council of State may perform any of the functions or take any steps which the Chairman of that Council is required or authorised by this Act to perform or to take, under such conditions as the said Chairman may deem necessary to lay down from time to time".

2. Amendment of laws. - The laws mentioned in the Schedule are hereby amended as provided therein.

3. Short title. - This decree shall be called the Security Amendment Decree, 1992.

SCHEDULE

(1) **Amendment of section 42 of Act 25 of 1965.** - Section 42 of the Civil Proceedings Evidence Act, 1965 is hereby amended by the addition of the following subsection, the existing section becoming subsection (1):

"(2) Nothing in subsection (1) contained shall be construed as compelling the Chairman of the Council of State whether as person, Head of State or lawful successor to the office bearers mentioned in section 37(2)(b) of the Republic of Ciskei Constitutional Decree, 1990 (Decree No. 45 of 1990) to give evidence in any civil proceedings or before any Commission of enquiry".

(2) **Amendment of section 206 of Act 57 of 1977.** - Section 206 of the Criminal Procedure Act, 1977 is hereby amended by the addition of the following subsection, the existing section becoming subsection (1):

"(2) Nothing in subsection (1) contained shall be construed as compelling the Chairman of the Council of State, whether as person, Head of State or lawful successor to the office bearers mentioned in section 37(2)(b) of the Republic of Ciskei Constitutional Decree, 1990 (Decree No. 45 of 1990), to give evidence in any criminal proceedings or at any inquest".

(3) **Amendment of section 2 of Act 19 of 1986.** - Section 2 of the Interpretation Act, 1986 is hereby amended by the substitution for the definition of "President", "President in Council" or "President in Executive Council" of the following definition:

"President", "President in Council", or "President in Executive Council" means the Chairman of the Council of State and includes, during the absence or incapacity of the Chairman, the Deputy Chairman of that Council;"
