BYLAE

Woordomskrywing

1. In hierdie Bylae beteken "die Regulasies" die Padverkeersregulasies gepubliseer by Goewermentskennisgewing No. R.910 van 26 April 1990, soos gewysig by Goewermentskennis-gewings Nos. R.1312 van 13 Junie 1990, R.1954 van 17 Augustus 1990, R.2066 van 31 Augustus 1990, R.2982 van 14 Desember 1990, R.125 van 14 Februarie 1991, R.1059 van 4 Junie 1991, R.2694 van 15 November 1991, R.1695 van 15 Junie 1992.

Invoeging van regulasie 239A in die Regulasies

2. Die volgende regulasie word hierby na regulasie 239 van die Regulasies ingevoeg:

"Magtiging wat dien as lisensie ingevolge artikel 15 van die Wet

239A. (1) 'n Behoorlik voltooide vorm KID of TBL soos in Bylae 2 aangedui, deur 'n toetsbeampte vir bestuurderslisensies of 'n persoon daartoe gemagtig uitgereik, ingevolge regulasie 247D, is 'n magtiging ingevolge artikel 15 van die Wet, vir 'n tydperk van twee maande na datum van uitreiking daarvan, of tot die datum waarop die persoon aan wie sodanige vorm uitgereik is, sy oorspronklike of duplikaat lisensie ontvang, watter datum ookal die vroegste is.

(2) (a) Behoudens die bepalings van paragrafe (b) en (c), is 'n deurslag van 'n beëdigde verklaring aangaande die diefstal, verlies, vernietiging of ontsiering van 'n lisensie wat by 'n bestuurderslisensie-toetsentrum of polisiekantoor afgeneem is en wat -

(i) die amptelike datumstempel van die betrokke owerheid, bevat;

(ii) die deponent se -

(aa) volle name;

(bb) identiteitsnommer of geboortedatum;

(cc) volle adres; en

(dd) kode lisensie met alle endossemente en beperkings daarop van toepassing,

bevat; en

(iii) die omstandighede waaronder sodanige lisensie gesteel, verlore, vernietig of ontsier is, beskryf,

'n magtiging ingevolge artikel 15 van die Wet.

(b) Indien die verklaring in paragraaf (a) bedoel by 'n polisiekantoor afgeneem is, moet die verklaring ook die misdad administrasiestelselnommer (MAS) of die voorvalleboeknommer (VB), na gelang van die geval, bevat.

(c) Die verklaring in paragraaf (a) bedoel is geldig vir 'n periode van drie dae na datum van uitreiking daarvan.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the Road Traffic Regulations published by Government Notice No. R.910 of 26 April 1990, as amended by Government Notices Nos. R.1312 of 13 June 1990, R.1954 of 17 August 1990, R.2066 of 31 August 1990, R.2982 of 14 December 1990, R.125 of 14 February 1991, R.1059 of 4 June 1991, R.2694 of 15 November 1991, R.1695 of 15 June 1992.

Insertion of regulation 239A in the Regulations

2. The following regulation is hereby inserted after regulation 239 of the Regulations:

"Authorization which serves as licence in terms of section 15 of the Act

239A. (1) A duly completed form RID or TDL as shown in Schedule 2, issued by an examiner for drivers' licences or a person authorized thereto in terms of regulation 247D shall be an authorization in terms of section 15 of the Act, for a period of two months after the date of issue thereof, or until the date on which the person to whom such form was issued, receives his original or duplicate licence, whichever date is the earlier.

(2) (a) Subject to the provisions of paragraphs (b) and (c), a carbon copy of an affidavit regarding the theft, loss, destruction or defacement of a licence administered at a driver's licence testing centre or police station and which -

(i) contains the official date stamp of the authority concerned;

(ii) contains the -

(aa) full names;

(bb) identity number or date of birth;

(cc) full address; and

(dd) code of licence with all endorsements and restrictions applicable thereto,

of the deponent; and

(iii) describes the circumstances under which such licence was stolen, lost, destroyed or defaced,

shall be an authorization in terms of section 15 of the Act.

(b) If the affidavit referred to in paragraph (a) is administered at a police station, such affidavit shall also contain the crime administration number (CAS) or the occurrence book number (OB), as the case may be.

(c) The affidavit referred to in paragraph (a) shall be valid for a period of three days after the date of issue thereof.

- (d) Die bestuurderslisensie-toetssentrum of polisiekantoor waar 'n beëdigde verklaring afgeneem word moet die oorspronklike verklaring vir rekorddoeleindes bewaar."

Wysiging van regulasie 245 van die Regulasies

3. Regulasie 245 van die Regulasies word hierby gewysig deur subregulasie (1) met die volgende subregulasie te vervang:

"(1) 'n Aansoek ingevolge artikel 24(1) of 28(3) van die Wet of 'n omruiling ingevolge artikel 29(3) van die Wet, word op vorm BL1 soos in Bylae 2 aangedui, gedoen en gaan vergesel van -

- (a) aanvaarbare identifikasie;
- (b) elke lisensie wat die aansoeker magtig om 'n motorvoertuig te bestuur; en
- (c) twee foto's van die applikant, in regulasie 242(1)(a) bedoel."

Wysiging van regulasie 247 van die Regulasies

4. Regulasie 247 van die Regulasies word hierby gewysig deur -

- (a) subregulasie (1) met die volgende subregulasie te vervang:

"(1) Indien die aansoeker in besit is van of in die proses is om 'n identiteitsdokument te verkry, magtig die toetsbeampste vir bestuurderslisensies of 'n persoon daartoe gemagtig, die uitreiking van 'n bestuurderslisensie op vorm BL2 soos in Bylae 2 aangedui en -

- (a) voltooi die magtiging vir die uitreiking van die bestuurderslisensie;
- (b) heg een foto aan sodanige magtiging en een foto aan die deurslag daarvan vas;
- (c) verseker dat die aansoeker sodanige magtiging teken;
- (d) heg een lamelleringstrook aan sodanige magtiging en 'n ander aan die deurslag daarvan vas, om die foto en persoonlike besonderhede van die houer te bedek;
- (e) behou die deurslag van sodanige magtiging vir rekord doeleindes;
- (f) lig die aansoeker in om onmiddellik vir 'n identiteitsdokument aansoek te doen; en
- (g) versend sodanige magtiging aan die Direkteur-generaal van Binnelandse Sake nie later nie as twee dae na die datum van uitreiking van sodanige magtiging."

- (b) subregulasies (2) en (3) te skrap.

- (d) The driver's licence testing centre or police station at which an affidavit is administered shall retain the original of such affidavit for record purposes."

Amendment of regulation 245 of the Regulations

3. Regulation 245 of the Regulations is hereby amended by the substitution for subregulation (1) of the following subregulation:

"(1) An application in terms of section 24(1) or 28(3) of the Act or an exchange in terms of section 29(3) of the Act, shall be made on form DL1 as shown in Schedule 2, and shall be accompanied by -

- (a) acceptable identification of the applicant;
- (b) every licence which authorizes the applicant to drive a motor vehicle; and
- (c) two photographs of the applicant, referred to in regulation 242(1) (a)."

Amendment of regulation 247 of the Regulations

4. Regulation 247 of the Regulations is hereby amended by -

- (a) the substitution for subregulation (1) of the following subregulation:

"(1) If the applicant is in possession of or in the process of obtaining an identity document, the examiner for drivers' licences or a person authorized thereto shall authorize the issue of a driver's licence on form DL2 as shown in Schedule 2, and shall-

- (a) complete the authorization to issue the driver's licence;
- (b) affix one photograph to such authorization and one photograph to the carbon copy thereof;
- (c) ensure that the applicant signs such authorization;
- (d) affix one lamination strip to such authorization and another to the carbon copy thereof, to cover the photograph and personal particulars of the holder;
- (e) retain the carbon copy of such authorization for record purposes;
- (f) inform the applicant to apply forthwith for an identity document; and
- (g) forward such authorization to the Director-General of Home Affairs not later than two days after the date of issue of such authorization."

- (b) the deletion of subregulations (2) and (3).

Wysiging van regulasie 247A van die Regulasies

5. Regulasie 247A van die Regulasies word hierby gewysig deur -

- (a) paragraaf (b) van subregulasie (1) met die volgende paragraaf te vervang:

"(b) twee foto's van die aansoeker, in regulasie 242(1)(a) bedoel; en"; en

- (b) paragraaf (b) van subregulasie (2) met die volgende paragraaf te vervang:

"(b) reik die duplikaat van 'n leerling- of bestuurderslisensie in ooreenstemming met regulasie 244 of 247 na gelang van die geval uit met die inskripsie "DUPLIKAAT" of "DUPLICATE" daarop gestempel."

Wysiging van regulasie 247C van die Regulasies

6. Regulasie 247C van die Regulasies word hierby gewysig deur -

- (a) subregulasie (1) met die volgende subregulasie te vervang:

"(1) Behoudens die bepalings van subregulasie (3), word 'n lisensie bedoel in artikel 28(1)(a)(i) van die Wet, wat uitgereik is terwyl die houer daarvan permanent of gewoonlik woonagtig was in sodanige voorgeskrewe gebied, gedurende die geldigheidsduur daarvan in sodanige voorgeskrewe gebied, geag 'n geldige lisensie vir die doeleindes van Hoofstuk III van die Wet te wees, indien -

- (a) (i) sodanige lisensie uitgereik is in 'n amptelike taal van die Republiek; of
- (ii) daar 'n sertifikaat van egtheid of geldigheid met betrekking tot sodanige lisensie in 'n amptelike taal van die Republiek, deur 'n bevoegde gesag uitgereik, of 'n vertaling van daardie lisensie in sodanige amptelike taal, daarby aangeheg is; en

- (b) sodanige lisensie 'n foto en die handtekening van die houer daarvan bevat of dit daarby aangeheg is.";

- (b) subregulasie (3) met die volgende subregulasie te vervang:

"(3) Wanneer die houer van 'n lisensie, bedoel in subregulasie (1) of (2), of die houer van 'n internasionale bestuurpermit, bedoel in artikel 28(1)(b) van die Wet -

- (a) na die Republiek terugkeer om permanente verblyf te hervat word sodanige lisensie of permit, nie langer geag 'n geldige lisensie vir die doeleindes van Hoofstuk III van die Wet te wees nie, na ses maande vanaf die datum van terugkeer;

Amendment of regulation 247A of the Regulations

5. Regulation 247A is hereby amended by -

- (a) the substitution for paragraph (b) of subregulation (1) of the following paragraph:

"(b) two photographs of the applicant, referred to in regulation 242 (1)(a); and"; and

- (b) the substitution for paragraph (b) of subregulation (2) of the following paragraph:

"(b) issue the duplicate of a learner's or driver's licence in accordance with regulation 244 or 247, as the case may be, with the inscription "DUPLICATE" or "DUPLIKAAT" stamped thereon."

Amendment of regulation 247C of the Regulations

6. Regulation 247C of the Regulations is hereby amended by -

- (a) the substitution for subregulation (1) of the following subregulation:

"(1) Subject to the provisions of subregulation (3), a licence referred to in section 28 (1)(a)(i) of the Act, issued while the holder thereof was permanently or ordinarily resident in such prescribed territory, shall, during the period of validity thereof in such territory, be deemed to be a valid licence for the purposes of Chapter III of the Act if -

- (a) (i) such licence has been issued in an official language of the Republic; or
- (ii) a certificate of authenticity or validity relating to such licence was issued in an official language of the Republic by a competent authority, or a translation of such licence in such official language, is attached thereto; and

- (b) such licence contains or has attached thereto a photograph and the signature of the holder thereof.";

- (b) the substitution for subregulation (3) of the following subregulation:

"(3) When the holder of a licence referred to in subregulation (1) or (2) or the holder of an international driving permit referred to in section 28 (1)(b) of the Act -

- (a) returns to the Republic to resume permanent residence such licence or permit shall no longer be deemed to be a valid licence for the purposes of Chapter III of the Act, after six months from the date of return;

- (b) toestemming ingevolge enige wet in die Republiek vir permanente verblyf verkry word, sodanige lisensie of permit nie langer geag 'n geldige lisensie vir die doeleindes van Hoofstuk III van die Wet te wees nie, na ses maande vanaf die datum waarop sodanige persoon permanente verblyf opgeneem het; of
- (c) in die geval waar sodanige lisensie uitgereik is in 'n selfregerende gebied en die houer daarvan permanent woonagtig word in enige gebied van die Republiek anders as die gebied van die selfregerende gebied word sodanige lisensie nie langer geag 'n geldige lisensie vir doeleindes van Hoofstuk III van die Wet te wees nie, na ses maande vanaf die datum waarop hy sodanig woonagtig geword het."

Invoeging van regulasie 247D in die Regulasies

7. Die volgende regulasie word hierby na regulasie 247C ingevoeg:

"Aansoek en uitreiking van magtiging wat dien as lisensie

247D. (1) 'n Persoon wat begerig is om vorm KID of TBL bedoel in regulasie 239A(1) te verkry, moet sodanige vorm versoek -

- (a) in die geval waar sodanige persoon sy bestuurderslisensietoets geslaag het en sodanige lisensie in die proses is om in sy identiteitsdokument vervat te word, by die bestuurderslisensie-toetssentrum wat die magtiging bedoel in regulasie 247(1) uitgereik het, en sodanige versoek gaan vergesel van -
 - (i) twee foto's van sodanige persoon, bedoel in regulasie 242(1)(a); en
 - (ii) die toepaslike gelde bedoel in Bylae 1; of
- (b) in die geval waar sodanige persoon se lisensie gesteel, verlore, vernietig of ontsier is, by enige bestuurderslisensie-toetssentrum en sodanige versoek gaan vergesel van -
 - (i) twee foto's van sodanige persoon, bedoel in regulasie 242(1)(a); en
 - (ii) die toepaslike gelde bedoel in Bylae 1.

(2) By ontvangs van die versoek bedoel in subregulasie (1) moet 'n toetsbeampde vir bestuurderslisensies of 'n persoon daartoe gemagtig -

- (a) (i) in die omstandighede bedoel in subregulasie (1)(a), vasstel wat die kode lisensie is wat vervat is in die magtiging bedoel in regulasie 247(1); of
- (ii) in die omstandighede bedoel in subregulasie (1)(b), vasstel of die persoon wel die houer van 'n geldige lisensie is;

- (b) obtains permission in terms of any law for permanent residence in the Republic, such licence or permit shall no longer be deemed to be a valid licence for the purposes of Chapter III of the Act, after six months from the date on which such person has taken up permanent residence; or

- (c) in the case where such licence was issued in a self-governing territory and the holder thereof becomes permanently resident in any area of the Republic other than the area of the self-governing territory, such licence shall no longer be deemed to be a valid licence for the purposes of Chapter III of the Act, after six months from the date he became so resident."

Insertion of regulation 247D in the Regulations

7. The following regulation is hereby inserted after regulation 247C:

"Application and issue of authorization which serves as licence

247D. (1) A person desiring to obtain form RID or TDL referred to in regulation 239A(1), shall request such form -

- (a) in the case where such person has passed his driver's licence test and such licence is in the process of being included in his identity document, at the driver's licence testing centre which issued the authorization referred to in regulation 247(1), and such request shall be accompanied by -
 - (i) two photographs of such person referred to in regulation 242(1)(a); and
 - (ii) the appropriate fee referred to in Schedule 1; or
- (b) in the case where such person's licence has been stolen, lost, destroyed or defaced, at any driver's licence testing centre and such request shall be accompanied by -
 - (i) two photographs of such person, referred to in regulation 242(1)(a); and
 - (ii) the appropriate fees referred to in Schedule 1.

(2) On receipt of the request referred to in subregulation (1) an examiner for drivers' licences or a person authorized thereto shall -

- (a) (i) in the circumstances referred to in subregulation (1)(a), determine the code of licence as contained in the authorization referred to in regulation 247(1); or
- (ii) in the circumstances referred to in subregulation (1)(b) determine whether the person is the holder of a valid licence;

- (b) vorm KID of TBL, soos in Bylae 2 aangedui, voltooi en die relevante kode lisensie langs die identiteitsnommer van sodanige persoon aantoon;
- (c) een foto aan die oorspronklike vorm en een foto aan die deurslag daarvan heg;
- (d) verseker dat sodanige persoon die vorm teken;
- (e) een lamelleringsstrook aan die oorspronklike vorm en een aan die deurslag daarvan heg om die foto, persoonlike besonderhede en kode lisensie van sodanige persoon te bedek;
- (f) in die geval van vorm KID, die inligting op die agterkant van die vorm kanselleer en by sodanige kansellasië teken; en
- (g) die oorspronklike vorm aan sodanige persoon uitreik en die deurslag daarvan vir rekord doeleindes behou."

Wysiging van regulasie 368 van die Regulasies

8. Regulasie 368 van die Regulasies word hierby gewysig deur -

- (a) paragraaf (b) met die volgende paragraaf te vervang:
- "(b) die toelaatbare maksimum voertuigmassa van die voertuig bedoel in regulasie 362C in kilogram (as V aangedui); en"; en
- (b) paragraaf (c) met die volgende paragraaf te vervang:
- "(c) indien die voertuig gebruik word om 'n ander voertuig te trek, die toelaatbare maksimum kombinasie-massa van sodanige voertuig bedoel in regulasie 362D in kilogram (as D/T aangedui);"

Wysiging van regulasie 369 van die Regulasies

9. Regulasie 369 van die Regulasies word hierby gewysig deur -

- (a) paragrawe (vii), (viii) en (ix) van paragraaf (b) van subregulasie (1) met die volgende subparagrawe te vervang:
- "(vii) die toelaatbare maksimum voertuigmassa bedoel in regulasie 362C in kilogram (as V aangedui);
- (viii) die toelaatbare maksimum asmassa as bedoel in regulasie 362A of aseenhedmassa as bedoel in regulasie 362B van elke as of aseenhed in kilogram (as A of AU/AE onderskeidelik aangedui); en
- (ix) die toelaatbare maksimum kombinasie-massa bedoel in regulasie 362D in kilogram (as D/T aangedui);"

- (b) complete form RID or TDL as shown in Schedule 2 and indicate the relevant code of driver's licence, next to the identity number of such person;
- (c) affix one photograph to the original form and one photograph to the carbon copy thereof;
- (d) ensure that such person signs the form;
- (e) affix one lamination strip to the original form and another to the carbon copy thereof to cover the photograph, personal particulars and code of licence of such person;
- (f) in the case of form RID, cancel the information contained on the reverse side of the form and sign such cancellation; and
- (g) issue the original form to such person and retain the carbon copy thereof for record purposes."

Amendment of regulation 368 of the Regulations

8. Regulation 368 of the Regulations is hereby amended by -

- (a) the substitution for paragraph (b) of the following paragraph:
- "(b) the permissible maximum vehicle mass referred to in regulation 362C in kilograms (denoted as V); and"; and
- (b) the substitution for paragraph (c) of the following paragraph:
- "(c) if the vehicle is used to draw any other vehicle, the permissible maximum combination mass of such vehicle referred to in regulation 362D in kilograms (denoted as D/T);"

Amendment of regulation 369 of the Regulations

9. Regulation 369 of the Regulations is hereby amended by -

- (a) the substitution for subparagraphs (vii), (viii) and (ix) of paragraph (b) of subregulation (1) of the following subparagraphs:
- "(vii) the permissible maximum vehicle mass referred to in regulation 362C in kilograms (denoted as V);
- (viii) the permissible maximum axle massload referred to in regulation 362A or axle unit massload referred to in regulation 362B of each axle or axle unit in kilograms (denoted as A or AU/AE respectively); and
- (ix) the permissible maximum combination mass referred to in regulation 362D in kilograms (denoted as D/T);"

(b) paragraaf (c) van subregulasie (2) met die volgende paragraaf te vervang:

"(c) die toelaatbare maksimum kombinasie-massa bedoel in regulasie 362D in kilogram (as D/T aangedui).".

Wysiging van regulasie 372 van die Regulasies

10. Regulasie 372 van die Regulasies word hierby gewysig deur subregulasie (1) met die volgende subregulasie te vervang:

"(1) Wanneer in enige vervolging weens 'n oortreding ingevolge regulasies 362A tot 367 ingesluit, 'n bewering in die klagstaat of dagvaarding gemaak word met betrekking tot -

- (a) die bruto voertuigmassa;
- (b) die bruto asmassalas;
- (c) die bruto aseenhedmassalas;
- (d) die bruto kombinasie-massa;
- (e) die netto drywing in kilowatt van enige bus of goederevoertuig;
- (f) die toelaatbare maksimum voertuigmassa bedoel in regulasie 362C;
- (g) die toelaatbare maksimum kombinasie-massa bedoel in regulasie 362D; of
- (h) die toelaatbare maksimum asmassalas of maksimum aseenhedmassalas bedoel in regulasie 362A of 362B onderskeidelik,

word sodanige bewering juis geag, totdat die teendeel bewys word."

Wysiging van regulasie 406G van die Regulasies

11. Regulasie 406G van die Regulasies word hierby gewysig deur paragraaf (d) met die volgende paragraaf te vervang:

"(d) word tesame met die teenblad daarvan binne 21 dae nadat 'n operateurskaart vir die betrokke motorvoertuig deur die operateur ontvang is, by die betrokke registrasie-oowerheid ingehandig."

Wysiging van Bylae 1 van die Regulasies

12. Bylae 1 van die Regulasies word hierby gewysig deur die volgende items na item 4A in te voeg:

(b) the substitution for paragraph (c) of subregulation (2) of the following paragraph:

"(c) the permissible maximum combination mass referred to in regulation 362D in kilograms (denoted as D/T).".

Amendment of regulation 372 of the Regulations

10. Regulation 372 of the Regulations is hereby amended by the substitution for subregulation (1) of the following subregulation:

"(1) If, in a prosecution for an offence under regulations 362A to 367 inclusive, an allegation is made in the charge sheet or summons in relation to-

- (a) the gross vehicle mass;
- (b) the gross axle mass;
- (c) the gross axle unit massload;
- (d) the gross combination mass;
- (e) the net power in kilowatts of any bus or goods vehicle;
- (f) the permissible maximum vehicle mass referred to in regulation 362C;
- (g) the permissible maximum combination mass referred to in regulation 362D; or
- (h) the permissible maximum axle massload or maximum axle unit massload, referred to in regulation 362A or 362B respectively,

such allegation shall be presumed to be correct, until the contrary is proved."

Amendment of regulation 406G of the Regulations

11. Regulation 406 G of the Regulations is hereby amended by the substitution for paragraph (d) of the following paragraph:

"(d) surrendered, with the counterfoil thereof within 21 days after an operator card for the motor vehicle concerned was received by the operator, to the registering authority concerned."

Amendment of Schedule 1 of the Regulations

12. Schedule 1 of the Regulations is hereby amended by the insertion of the following items after item 4A:

Wysiging van Bylae 2 van die Regulasies

13. Bylae 2 van die Regulasies word hierby gewysig deur -

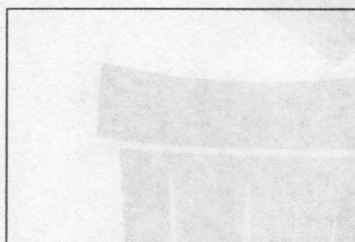

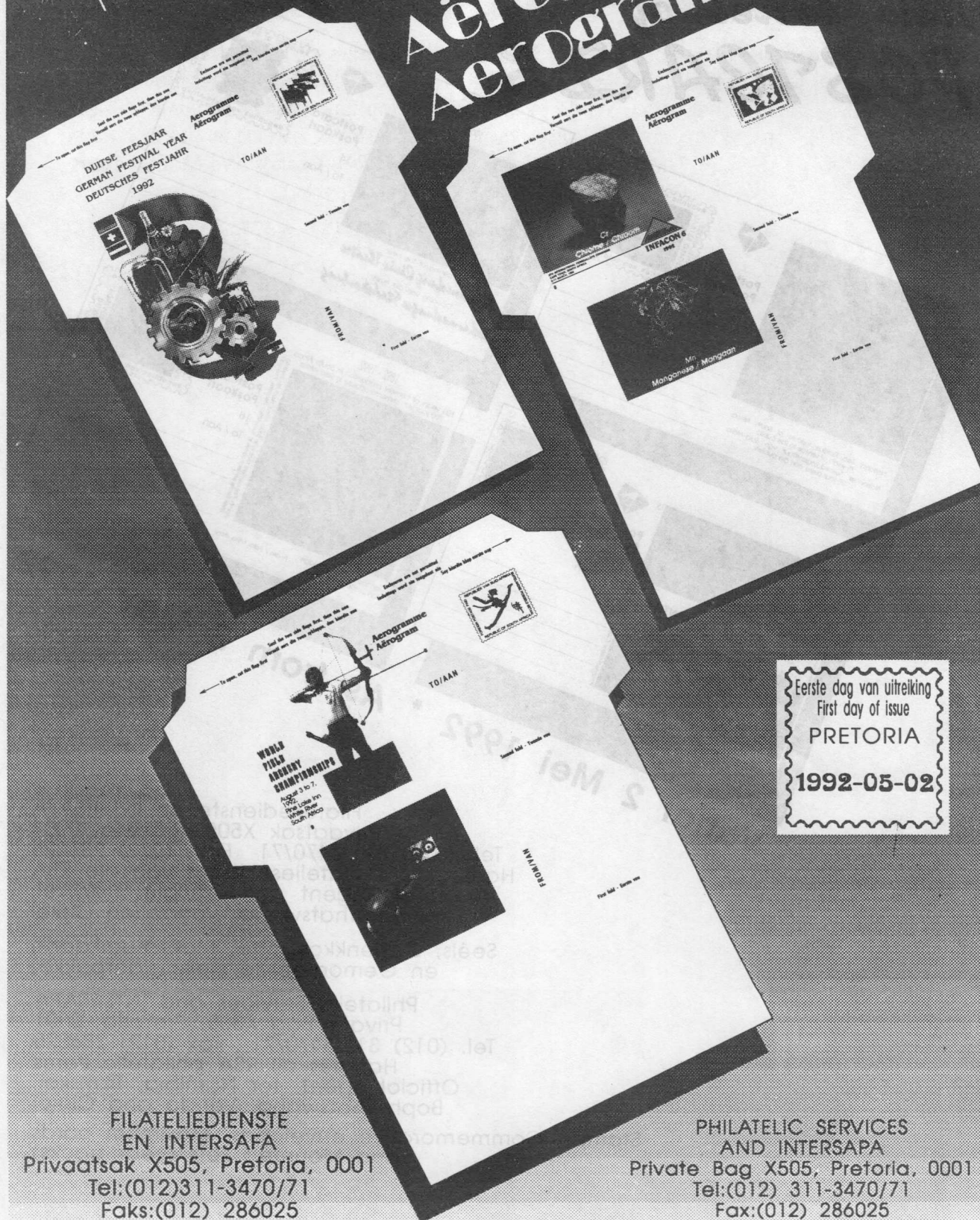

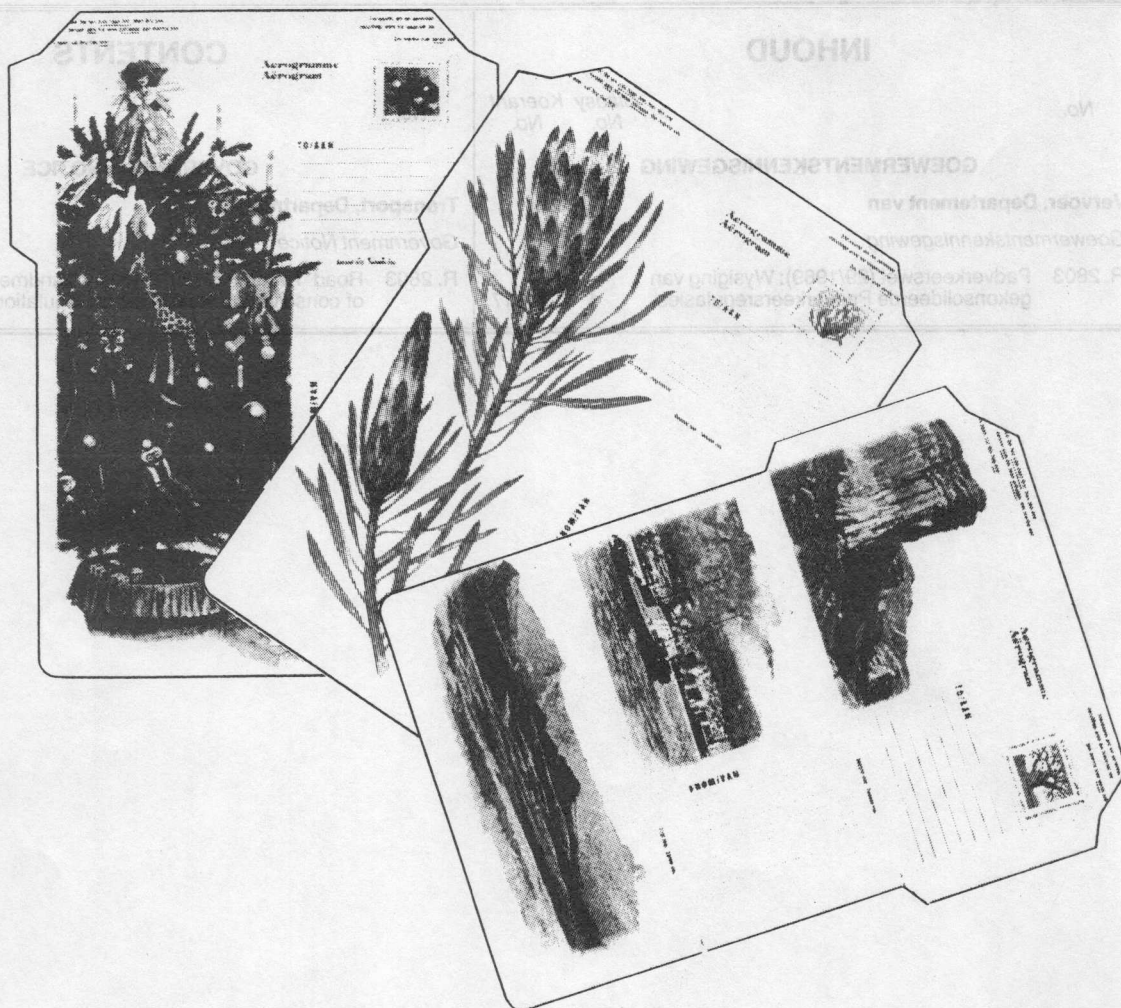
