NOTICE IN TERMS OF SECTION 9A OF THE WATER ACT, 1956

PROHIBITION ON THE ABSTRACTION AND A CURTAILMENT OF THE USE OF PUBLIC WATER FOR AGRICULTURAL PURPOSES FROM THE KAAP RIVER WITHIN THE LOWER KAAP RIVER AND EUREKA IRRIGATION DISTRICTS ON CERTAIN DAYS OF THE WEEK

By virtue of the powers vested in me by section 9A of the Water Act, 1956 (Act 54 of 1956) —

1. I, Magnus André de Merindol Malan, in my capacity as Minister of Water Affairs and Forestry, hereby declare that a water shortage is being experienced in the Lower Kaap River and Eureka Irrigation Districts;

2. I hereby direct, with respect to the area downstream of the confluence of the North and South Kaap Rivers up to the farm bordering the Crocodile River (Eastern Transvaal) Government Water Control Area at the point of confluence of the Kaap River and the Crocodile River (Eastern Transvaal), that the following restrictions on the abstraction of public water for agricultural purposes from the Kaap River shall be applicable:

2.1 No irrigation in this area is permitted on Saturdays and Sundays.

2.2 Irrigation is permitted only on the following days during the times indicated:

NOTICE OF INITIATION OF AN INVESTIGATION INTO THE ALLEGED DUMPING OF CALCIUM PROPIONATE AND CALCIUM ACETATE ORIGINATING IN THE NETHERLANDS, CANADA AND THE USA

The Board on Tariffs and Trade received a complaint alleging that imports of calcium propionate and calcium acetate originating in the Netherlands, Canada and the USA were being dumped, thereby causing material injury to the South African industry.

The applicant

The complaint was lodged by Chempro, the sole local manufacturer of calcium propionate and calcium acetate. The applicant alleges that the increased exports of calcium propionate and calcium acetate at prices lower than his manufacturing cost are causing him material injury. To justify an investigation of the complaint, the applicant submitted sufficient evidence of dumping, material damage and the causal connection.

The products

The products allegedly being dumped are calcium propionate and calcium acetate, classifiable under tariff subheadings 2915.50.30 and 2915.29.20 respectively.

The allegation of dumping

The allegation of dumping is based on a comparison between the current domestic values on the markets of The Netherlands, Canada and the USA, and the invoice price of exports to South Africa. On this basis the estimated dumping margin is significant.

Die Raad op Tariewe en Handel het 'n klag ontvang waarin beweer word dat ingevoerde kalsiumpropionaat en kalsiumasetaat, afkomstig van Nederland, Kanada en die VSA, gedump word en wesenlike skade aan die Suid-Afrikaanse nywerheid berokken.

Applikant

Die klag is ingedien deur Chempro, die enigste plaaslike vervaardiger van kalsiumpropionaat en kalsiumasetaat. Die applikant beweer dat die verhoogde uitvoer van kalsiumpropionaat en kalsiumasetaat teen pryse laer as die binnelandse vervaardigingskoste daarvan vir hom wesenlike skade veroorsaak. Ter regverdiging van 'n ondersoek na die klag, het die applikant voldoende bewyse van dumping, wesenlike skade en die kousale verband voorgeleë.

Produkte

Die produkte wat na bewering gedump word, is kalsiumpropionaat en kalsiumasetaat, indeelbaar by tariefsubposte 2915.50.30 en 2915.29.20 onderskeidelik.

Bewering van dumping

Die bewering van dumping of gesubsidieerde uitvoer is gebaseer op 'n vergelyking tussen die huidige binnelandse prys op die markte van Nederland, Kanada en die VSA en die faktuurprys van uitvoer na Suid-Afrika. Op hierdie basis is die beraamde marge van dumping aansienlik.

Allegation of material injury and causality

With regard to injury, the applicant alleges that the total imports of calcium propionate from the Netherlands increased from 21 tons in 1990 to 300 tons in 1991, an increase of 1 300%. This represents an increase in the market share held by Netherlands exporters from 3% in 1990 to 40% in 1991 at the expense of the South African manufacturer, whose market share fell from 95% to 52% during the same period. During the same period imports from Canada increased from 0 to 22 tons and imports from the USA from 0,012 tons (12 kg) to 33,5 tons.

Imports of calcium acetate from The Netherlands increased from 1 034 tons in 1990 to 1 438 tons in 1991, an increase of 39% and an increase in market share from 60% to 96% during the same period.

It is further alleged that the prices at which these imports are sold in South Africa are significantly lower than the prices charged by the South African manufacturer, which has been forced to reduce its prices to a level insufficient in order to cover its costs.

The consequent impact of these imports on the South African industry is claimed to be a reduction in production volumes from 805 tons in 1990 to 695 tons in 1991 (a decrease of 14%) and a projected further reduction of 47% to 370 tons in 1992. During 1991 the South African manufacturer had to curtail its production drastically owing to these imports.

Procedure

Having decided that there is sufficient evidence to justify the initiation of an investigation, the Board has commenced an investigation in terms of section 4 of the Board on Tariffs and Trade Act, 1986. Interested parties may submit their views in writing, preferably by completing the questionnaire sent to the parties known to be interested, and by providing supporting evidence. Copies of the questionnaire are available at the Office of the Board. The Board will hear parties who, in the submission of their views, request to be heard, provided they can prove that they are likely to be affected by the outcome of the investigation.

Time limit

Any information relating to this matter, any argument concerning the allegation of dumping and material injury resulting therefrom, and any request for a hearing must be submitted in writing and must reach the **Chairman, Board on Tariffs and Trade, Private Bag X753, Pretoria, 0001**, not later than **30 days** after the publication of the official notice or, in the case of parties known to be interested, 30 days after the date on which the letter accompanying the above-mentioned questionnaire was received. The said letter will be deemed to have been received seven days after the date of its dispatch.

If the required information and arguments are not received in a satisfactory form within the time limit specified above, the Board may make preliminary or final findings on the basis of the facts at its disposal.

Bewering van wesenlike skade en van kousaliteit

Met betrekking tot wesenlike skade beweer die applikant dat invoer van kalsiumpropionaat uit Nederland toegeneem het van 21 ton in 1990 tot 300 ton in 1991, d.w.s. 'n toename van 1 300%. Dit verteenwoordig 'n toename in die marktaandeel gehou deur Nederlandse uitvoerders van 3% in 1990 tot 40% in 1991, ten koste van die Suid-Afrikaanse vervaardiger, wie se marktaandeel gedurende dieselfde tydperk van 95% tot 52% gedaal het. Gedurende dieselfde tydperk het invoer uit Kanada toegeneem van 0 tot 22 ton en uit die VSA van 0,012 ton (12 kg) tot 33,5 ton.

Invoer van kalsiumasetaat uit Nederland het toegeneem van 1 034 ton in 1990 tot 1 438 ton in 1991, 'n toename van 39% en 'n toename in marktaandeel van 69% tot 96% gedurende dieselfde tydperk.

Daar word verder beweer dat die pryse waarteen die ingevoerde produkte op die Suid-Afrikaanse mark verkoop word, beduidend laer is as die pryse wat gevra word deur die plaaslike vervaardiger, wat daardeur gedwing word om sy pryse te verlaag tot 'n vlak wat onvoldoende is om sy koste te dek. Die uitwerking wat die invoer op die Suid-Afrikaanse bedryf het, is 'n beweerde verlaging in produksievolumes van 805 ton in 1990 tot 695 ton in 1991 ('n daling van 14%) en 'n geprojekteerde verdere daling van 47% tot 370 ton in 1992. As gevolg van die invoer moes die Suid-Afrikaanse vervaardiger sy produksie gedurende 1991 drasties inkort.

Prosedure

Na die besluit dat daar voldoende bewyse is ter regverdiging van 'n ondersoek, het die Raad begin met 'n ondersoek ingevolge artikel 4 van die Wet op Tariewe en Handel, 1986. Belanghebbende partye kan hul siening skriftelik indien, verkieslik deur die invul van 'n vraelys wat gestuur word aan partye wat betrokke is, en deur voorlegging van stawende bewyse. Afskrifte van die vraelys is ook by die Kantore van die Raad beskikbaar.
