LOCAL GOVERNMENT TRAINING ACT, 1985

#### IMPOSITION OF TRAINING LEVY

I, Roelf Petrus Meyer, Minister of Provincial Affairs and Constitutional Development, by virtue of the powers vested in me in terms of section 10 of the Local Government Training Act, 1985 (Act No. 41 of 1985), and after consultation with the Minister of Finance and the Training Board, do hereby impose a training levy as set out in the accompanying Schedule and payable by local government bodies in general, with the exception of regional services councils.

The training levy is payable to the Director-General: Department of Constitutional Development (Training Fund), 260 Walker Street, Sunnyside, Pretoria, or Private Bag X804, Pretoria, 0001.

#### SCHEDULE

An amount of 0,01 cent per rand based upon the total income according to the annual operating budget of a local government body for the year 1994/95: Provided that such levy shall be payable on or before 30 June 1995.
