ERRATA: GOVERNMENT GAZETTE No. 17781 DATED 14 FEBRUARY 1997

The South African Roads Board hereby, in terms of section 9 (1) (a) of the National Roads Act, 1971 (Act No. 54 of 1971), as amended, hereby amends *Government Gazette* No. 17781 dated 14 February 1977, as follows:

(A) Government Notice No. 240: By substituting—

- (i) the toll tariff of "CLASS IV: R24,00" where it appears in paragraph 4.3, for "CLASS IV: R12,00";
- (ii) the toll tariff of "CLASS IV: R12,00" where it appears in paragraph 4.4, for "CLASS IV: R24,00"; and
- (iii) the phrase "*bona fide* residents of the Magisterial Districts of Estcourt, Bergville, Glencoe, Weenen or Klip River" where it appears in paragraphs 4.3 and 4.4 for the phrase "*bona fide* residents of the Magisterial Districts of Estcourt, Bergville, Glencoe, Weenen, Klip River or Dundee"; and

- (B) Government Notice No. 245: By substituting the phrase "for 34 to 69 trips per calendar month in any direction" where it appears in paragraph 4: CLASS I (a) for the phrase "for 35 to 69 trips per calendar month in any direction".
