SOUTH AFRICAN ROADS BOARD

REPEAL OF GOVERNMENT NOTICE No. 969 OF 1996 AND INTENTION TO REDECLARE A CONTINUOUS TOLL ROAD FROM THE GAUTENG BOUNDARY TO KOMATIPOORT TO BRING THE DESCRIPTION UP TO DATE AND TO INCLUDE SECTION 6Y OF THIS ROUTE THROUGH SCHOEMANSKLOOF: PROVINCE OF MPUMALANGA

1. In terms of section 9 (1) (a) of the National Roads Act, 1971 (Act No. 54 of 1971), the South African Roads Board hereby withdraws Government Notice No. 969 of 1996 and notifies all interested parties of its intention to declare, under section 9 of the National Roads Act, 1971, the following sections of National Route 4 to be a toll road:

Sections 3, 4, 5, 5X, 6X, 6Y, 7X and 8X, as declared by Government Notices Nos. 116 of 1985, 190 of 1985, 296 of 1972, 358 of 1977, 160 of 1986 (as amended by Government Notice No. 649 of 1997), 186 of 1987, 652 of 1997, R. 650 of 1997, 188 of 1985, 2014 of 1990 and R. 651 of 1997, commencing at the provincial boundary which coincides with the boundary between the farms Spitskop 533-JR (in Bronkhorstspuit District) and Eenzaamheid 534-JR (in Witbank District) and ending on the farm Customs Site Reserve 183-JU at the Mozambique border.

2. In terms of section 9 (3) (c) of the National Roads Act, 1971, all interested parties are hereby invited to make written representations, *within 30 days from the date of this notice*, to the South African Roads Board on the proposed redeclaration of the said sections of National Route 4 as a continuous toll road. These representations must be addressed to the **Chairman of the Board, P.O. Box 415, Pretoria, Gauteng, 0001.**

3. In terms of section 9 (3) (d) of the National Roads Act, 1971, a schematic indication of the approximate position of the proposed toll gates is given in the Schedule.

1. 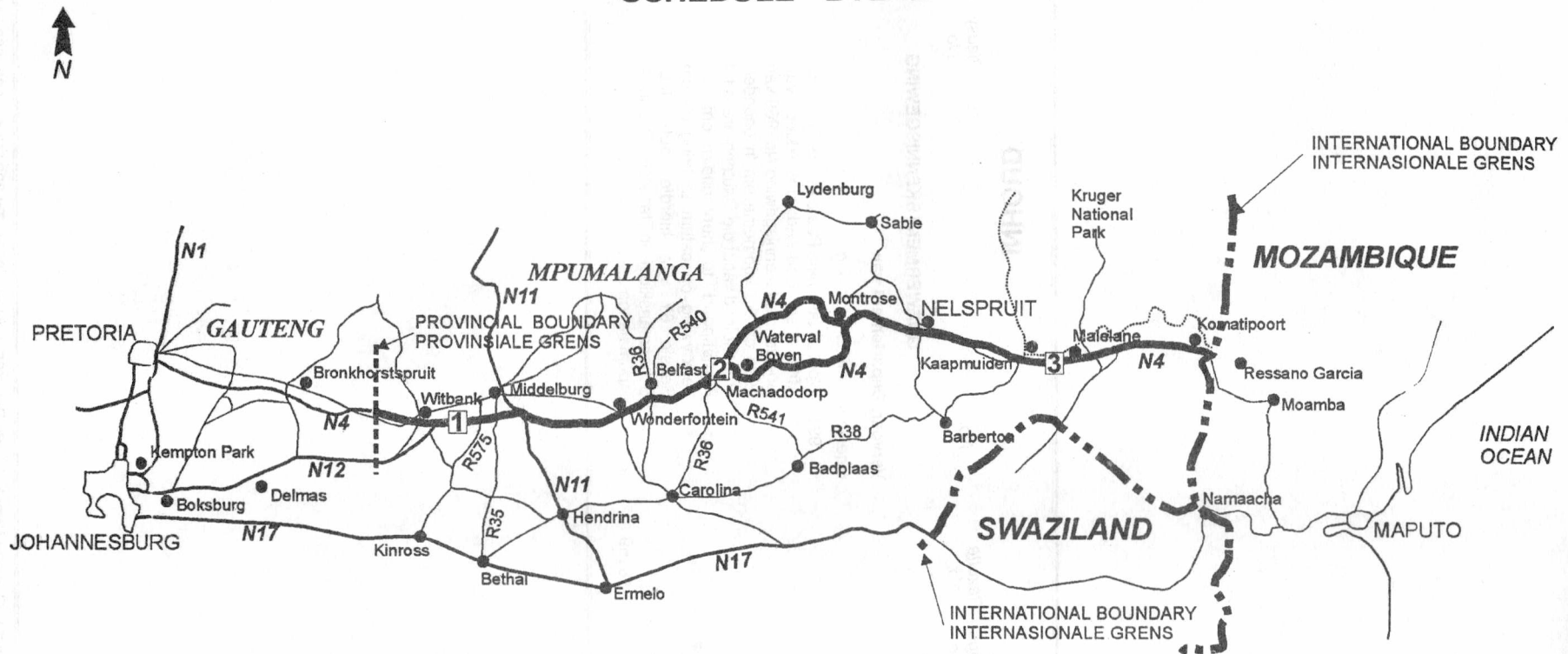
Seksies 3, 4, 5, 5X, 6X, 6Y, 7X en 8X, soos verklaar by Goewermenskennisgewings Nos. 116 van 1985, 190 van 1985, 296 van 1972, 358 van 1977, 160 van 1986 (soos gewysig by Goewermenskennisgewing No. 649 van 1997), 1986 van 1987, 652 van 1997, R. 650 van 1997, 188 van 1985, 2014 van 1990 en R. 651 van 1997, wat begin by die provinsiale grens wat saamval met die grens tussen die plase Spitskop 533-JR (in die distrik Bronkhorstspuit) en Eenzaamheid 534-JR (in die distrik Witbank) en eindig op die plaas Customs Site Reserve 183-JU by die grens van Mosambiek.

2.
