APPROVAL FOR THE INSTITUTION OF A COMMITTEE TO REVIEW THE COMMENTS ON THE DRAFT STATEMENT ON THE NATIONAL CURRICULUM FOR GRADES 1-9

On 6 June 1997 the document, **Draft Statement on the National Curriculum for Grades 1-9** was gazetted allowing interested parties to forward comments to the Department of Education.

In view of the large number of comments received it was deemed essential that a Review Committee should be instituted with a brief to analyse and summarise all received comments on the *Draft Statement on the National Curriculum for Grades 1-9*, and to adapt the afore-mentioned document accordingly.

Now, therefore, I, Sibusiso Mandlenkosi Emmanuel Bengu, Minister of Education, in terms of section 3 (4) (1) of the *National Education Policy Act, 1996 (Act No. 27 of 1996)*, hereby approve the institution of such Review Committee, comprising the following members:

- (i) The Chairperson of the Technical Committee, Mr J. Mathfield, a school principal in KwaZulu-Natal;
- (ii) three specialists from the Technical Committee who assisted in the writing of standards and frameworks for learning programmes, one from each phase, viz Foundation, Intermediate and Senior Phase;

Ms S. Sithole, Foundation Phase, from the KwaZulu-Natal Department of Education;
Dr B. Huyshamer, Intermediate Phase, from the Free State Department of Education; Mr M. Kibi,
Senior Phase from the Department of Education; and

- (iii) a Chairperson and Secretariat to be supplied by the Department of Education, namely:

Ms S. Hendricks, Chairperson; and

Dr K. Swart, Secretariat.
