## PROCLAMATION

*by the*

*Acting President of the Republic of South Africa*

No. R. 57, 1997

### REMUNERATION AND ALLOWANCES OF MEMBERS OF THE NATIONAL ASSEMBLY AND PERMANENT DELEGATES TO THE NATIONAL COUNCIL OF PROVINCES

In terms of section 2 (1) of the Payment of Members of Parliament Act, 1994 (Act No. 6 of 1994) (hereinafter referred to as the Act), read with section 85 (2) (e) of and items 2 (1) and 3 (1) (b) of Schedule 6 to the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996) (hereinafter referred to as the Constitution), and having given due regard to the recommendations of the Commission on Remuneration of Representatives published in Government Notice No. R. 1983 of 29 November 1996, I hereby determine that the annual remuneration and allowances for the various grades of Members and office-bearers of Parliament specified in column 1 of the Schedules shall be as follows:

- (a) In respect of Grades A1, B and C2, the remuneration and allowances specified in column 2 of Schedule A shall be applicable with effect from 1 July 1996 up to and including 31 December 1996.
- (b) In respect of Grades A1, B, C2, C1, D2, D1 and E2, the remuneration and allowances specified in column 2 of Schedule B shall be applicable with effect from 1 January 1997.
- (c) In respect of Grade F, the remuneration and allowances specified in column 2 of Schedule B shall be applicable with effect from 1 April 1997:

Provided that the provisions of paragraphs (b) and (c) shall apply only to a person who, on or after the date of this Proclamation, is or becomes a Member of the National Assembly or a Permanent Delegate to the National Council of Provinces.

In terms of section 2 (3) of the Act I determine the amount of R40 000 per annum as that portion of the Remuneration of a Member of Parliament to which paragraph (d) of section 8 (1) of the Income Tax Act, 1962 (Act No. 58 of 1962), shall apply with effect from 1 March 1997.

In this Proclamation, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Act, the Constitution, or in the Rules and Orders contemplated in sections 57 and 70 of the Constitution, shall bear that meaning, and

**"Whip"** means a Whip (other than the Chief Whip and Deputy Chief Whip of the Majority Party and the Chief Whip of the Largest Minority Party) for any political party represented in a House, designated by the leader of that party in that House, and approved in writing by the Speaker of the National Assembly or the Chairperson of the National Council of Provinces, as the case may be, as being reasonably necessary for the smooth working of Parliament.

Proclamation No. 85, 1995, of 22 September 1995 is hereby repealed.

## BESOLDIGING EN TOELAES VAN LEDE VAN DIE NASIONALE VERGADERING EN VASTE AFGEVAARDIGDES NA DIE NASIONALE RAAD VAN PROVINSIES

Ingevolge artikel 2 (1) van die Wet op die Betaling van Parlementslede, 1994 (Wet No. 6 van 1994) (hieronder die Wet genoem), saamgelees met artikel 85 (2) (e) van, en items 2 (1) en 3 (1) (b) van Bylae 6 by die Grondwet van die Republiek van Suid-Afrika, 1996 (Wet No. 108 van 1996) (hieronder die Grondwet genoem), en met behoorlike inagneming van die aanbevelings van die Kommissie op Besoldiging van Verteenwoordigers gepubliseer in Goewermenskennisgewing No. R. 1983 van 29 November 1996, bepaal ek hierby dat die jaarlikse besoldiging en toelaes vir die onderskeie grade Lede en ampsdraers van die Parlement in kolom 1 van die Bylaes vermeld, soos volg is:

- (a) Ten opsigte van Grade A1, B en C2, is die besoldiging en toelae in kolom 2 van Bylae A vermeld, van toepassing met ingang van 1 Julie 1996 tot en met 31 Desember 1996.
- (b) Ten opsigte van Grade A1, B, C2, C1, D2, D1 en E2, is die besoldiging en toelae in kolom 2 van Bylae B vermeld, van toepassing met ingang van 1 Januarie 1997.
- (c) Ten opsigte van Graad F, is die besoldiging en toelae in kolom 2 van Bylae B vermeld, van toepassing met ingang van 1 April 1997:

Met dien verstande dat die bepalings van paragrawe (b) en (c) van toepassing is slegs op iemand wat op of na die datum van hierdie Proklamasie 'n lid van die Nasionale Vergadering of 'n Vaste Afgevaardigde na die Nasionale Raad van Provinsies is of word.

Ingevolge artikel 2 (3) van die Wet bepaal ek die bedrag van R40 000 per jaar as daardie gedeelte van die besoldiging van 'n Lid van die Parlement waarop paragraaf (d) van artikel 8 (1) van die Inkomstebelastingwet, 1962 (Wet No. 58 van 1962), met ingang van 1 Maart 1997 van toepassing is.

In hierdie Proklamasie, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan 'n betekenis in die Wet, die Grondwet, of die Reëls en Orders in artikels 57 en 70 van die Grondwet beoog, toegeskryf is, daardie betekenis, en beteken—

**“Sweep”** 'n Sweep (behalwe die HoofswEEP en die AdjunkhoofswEEP van die Meerderheidsparty en die HoofswEEP van die Grootste Minderheidsparty) van enige politieke party in 'n Huis verteenwoordig wat deur die leier van daardie party in dié Huis aangewys word en wat skriftelik deur die Speaker van die Nasionale Vergadering of die Voorsitter van die Nasionale Raad van Provinsies, na gelang van die geval, goedgekeur word as redelikerwys nodig vir die vlot werking van die Parlement.

Proklamasie No. 85, 1995, van 22 September 1995 word hierby herroep.
