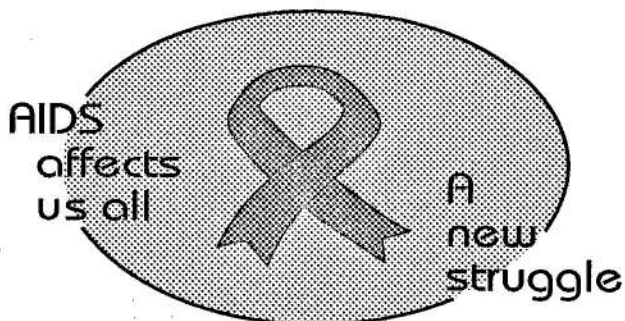

INDEPENDENT BROADCASTING AUTHORITY

APPLICATION FOR PUBLIC BROADCASTING SERVICE RADIO STATION: XHOISAN COMMUNITY RADIO

The independent Broadcasting Authority (the Authority) hereby gives notice in accordance with section 52 (2) of the Independent Broadcasting Authority Act No. 153 of 1993, as amended, that an amendment to the Public Sound Broadcasting Licence of the SABC and the signal Distribution Licence of Sentech as set out below.

The Authority recommended in its Triple Inquiry Report, of 1995 that the public broadcasting service language stations be upgraded to reach 80% of the people who speak the principle languages of the respective stations. In an effort to expedite the delivery to under-serviced language groups, the Authority decided on 19 May 1999 / 26 May 1999 to consider the SABC's application for expansion.

Take notice that in order to comply with the provisions of Section 52 (1) (c), the following amendment to the licence of the SABC is applied for, for the expansion of the Public Broadcasting Service Languages stations. Sentech is the nominated signal distribution operator.
