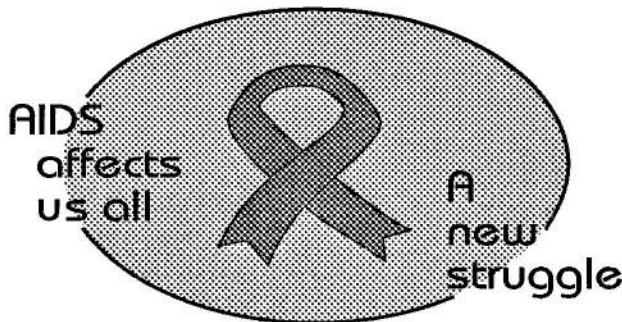

### INDEPENDENT BROADCASTING AUTHORITY

#### **NOTICE OF THE INDEPENDENT BROADCASTING AUTHORITY'S DECISIONS REGARDING THE APPLICATION BY KAYA FM (Pty) LTD FOR AMENDMENT OF CERTAIN OF ITS LICENCE CONDITIONS**

The Independent Broadcasting Authority hereby gives notice in accordance with section 52 (4) of the Independent Broadcasting Authority Act, no 153 of 1993, as amended, that it has decided as stated below, in respect of the application by Kaya FM (Pty) Ltd for the amendment of certain of its licence conditions. Kaya FM (Pty) Ltd submitted its application on ??? 1999. It was published in the *Government Gazette* No. 20766 Notice No. 2900 of 22 December 1999. A hearing was held on 8 March and 4 May 2000. The Authority decided that:

1. The acquisition of shares in Kaya FM (Pty) Ltd by Makana Investments (Pty) Ltd (Makana) and New Africa Media Holding (Pty) Ltd (NAM) is approved.
2. Increase of transmitter power at Brixton site from 3KW to 10 KW is approved.
3. The installation of a relay transmitter to cover Pretoria Metropolitan area and beyond is refused.
4. The intention by Moribo Investments (Thebe Convergent Technology Holdings) (Pty) Ltd to sell 5% of its shares in the future is refused?? (this was not mentioned in our 24 May letter to them. Perhaps we need to send another letter pointing this out)
5. The Authority is still considering application for approval of the dilution of minority shareholders, Mokgosi Music CC and Segwapa Music CC which resulted in an increase of shares held by Independent Newspapers.

The effective date of the amendments is the 24<sup>th</sup> of May 2000.

The Authority's reasons for its decisions would be made available in due course.
