The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations, name and special name. 1. Applicant: Production Management Institute of Southern Africa (Pty) Ltd. (H4/3/1/3935).

Arms: Or, a triquetra Azure interlaced through a cogwheel voided Sable; a chief nowy Azure.

Crest: Two pallets embowed back to back, the upper ends barbed Sable and a quillpen erect Azure, passing through a cogwheel voided Or.

Wreath and mantling: Azure and Or.

Motto: SCIENTIA AC INNOVATIO.

2. Applicant: North West Hunting and Nature Conservation Association (H4/3/1/3939).

Badge: A reedbuck head affronté, the neck coupé per chevron inverted proper, within a fillet annulet Brunâtre.

3. Applicant: Manala Mahagagwa Traditional Authority (H4/3/1/3950).

Arms: Or, two knobkieries in saltire Sable, with plumes pendant beneath two heads proper, between in chief the head of a black wildebeest coupé proper and in base the head of a polled cow coupé, Gules. Behind the shield a plumed spine and two spears in saltire, proper.

4. Applicant: BSL Professional Services (Pty) Ltd (H4/3/1/3954).

Arms: Per fess enhanced enarched Azure and Vert, over the partition a fess, the upper edge enarched and the lower incised of three arches Or, in chief three trefoils Argent and in base a cogwheel voided Or, surmounted by two lightning flashes in saltire issuant, per chevron reversed, Argent.

Crest: A survey beacon Argent, the vane Azure, within a wreath of two ears of wheat Or, the slips Vert.

Wreath and mantling: Vert and Or.

Motto: DIENSLEWERING DEUR SAMEWERKING.

5. Applicant: Structured Risks Solutions (Pty) Ltd (H4/3/1/3955).

Arms: Per fess enhanced, Or and Azure, in chief a balance of the last and in base a lion rampant Or, armed and langued Gules, holding a parchment scroll unfurled, Argent.

Crest: A lion passant Azure, armed and langued Gules, holding with the dexter forepaw a pike erect Sable, floting therefrom a swallow-tailed pennant Argent, charged with two quill-pens in saltire Gules.

Wreath and mantling: Azure and Or.

Motto: ULTIMA FIDES.

6. Applicant: Kranspoort Eienaarskomitee (H4/3/1/3956).

Arms: Per fess, against each flank a merlon and nowy per chevron inverted to base, Or and Vert, a tree aloof on an island counterchanged with three racemes Gules, and in chief a leaping impala in full course proper.

Crest: Perched on a mural crown Vert, a Woodland Kingfisher proper.

Mantling: Vert and Or.

Motto: RELAXO IN NATURA

7. Applicant: Iron Legion Motor Cycle Club of South Africa (H4/3/1/3957).

Badge: On a background Or, a motor cycle contourné, within an open wreath of two chains, crossed below and padlocked, proper.

Name: Iron Legion Motorcycle Club of South Africa.

Special name: Iron Legion MCC.

8. Applicant: South African National Blood Service (H4/3/1/3959)

Arms: Quarterly, Gules and Argent, a goutte and in chief two hearts, counterchanged.

Crest: Within a protea wreath, the blossoms Gules seeded Argent, slipped and leaved Vert, a goutte the lower curve fracted to sinister and curving inward, into the form of a stylised human heart, all in umbra, Gules.

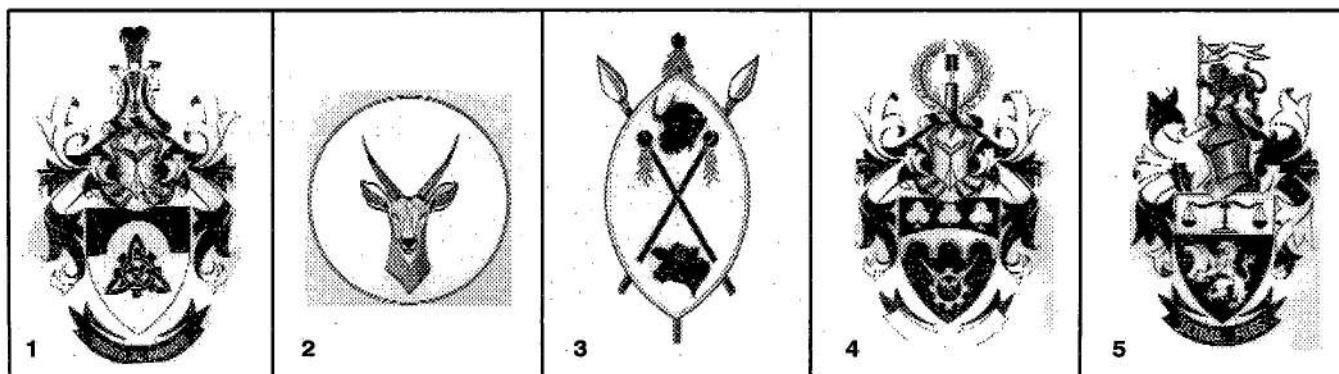

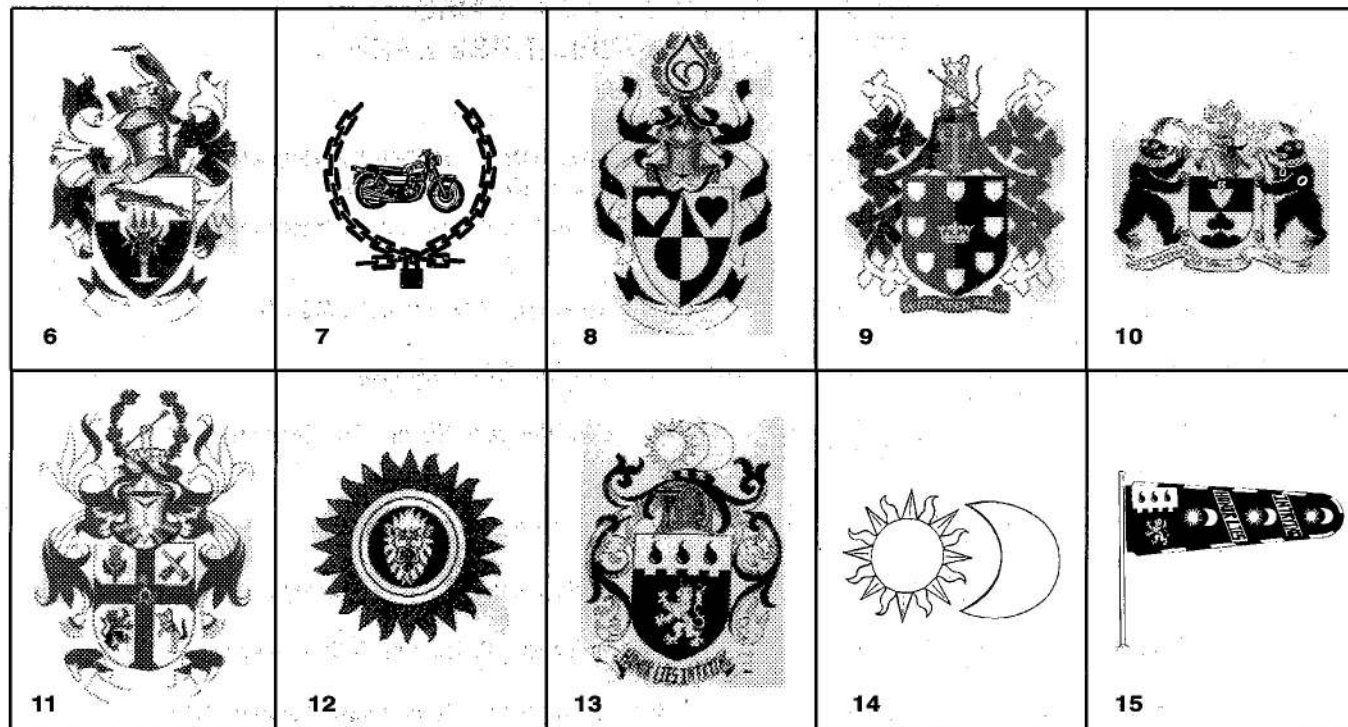

REGULATION MADE UNDER THE SECURITY OFFICERS ACT, 1987 (ACT NO. 92 OF 1987)

The Security Officers' Interim Board has, with the concurrence of the Deputy Minister for Safety and Security, acting on behalf of and on assignment by the Minister for Safety and Security, under section 32 of the Security Officers Act, 1987 (Act No. 92 of 1987), made the regulation set out in the Schedule.

Definition

1. In this regulation "the Regulations" means the regulations published by Government Notice No. R. 797 of 2 April 1990 as amended.

Amendment of regulation 9 of the Regulations

Amendment of regulation 9 of the Regulations

2. Regulation 9 of the Regulations is hereby amended by the substitution in subparagraph (ii) of paragraph (a) of subregulation (2) for the expression "R38,00 (excluding VAT)" of the expression "R42.20 (excluding VAT)".

Commencement

3. This regulation shall come into operation on **4 September 2001**.

SECURITY OFFICERS' INTERIM BOARD**Explanatory memorandum regarding proposed amendment to the Regulations**

1. The proposed amendment to the Regulations deals with an increase of the prescribed application fee which is payable in accordance with section 11(1)(b) of the Security Officers Act, 1987 (Act No. 92 of 1987).
2. The increase is the necessary consequence of an increase by the South African Police Service in respect of tariffs payable for services rendered by State Departments (in this instance the SAPS) to private institutions. The nature of the service that is applicable in this instance, is the classification and detection of fingerprints for other institutions.
3. The Interim Board has no other reasonable option but to transfer such increased costs to applicant security officers.

Rule 81.1.1.1.(a)

In the case of a member originally instructed before the granting of a judgment, and also in the case of every member who receives instructions thereafter but before the granting of the judgment, instruction charges of -

- (i) (R20) R50 for claims of R1 up to R1500.
- (ii) (R40) R100 for claims of over R1500 up to R5000.
- (iii) (R75) R150 for claims of over R5000 up to R10 000.
- (iv) (R120) R200 for claims over R10 000.

Rule 81.1.1.1.(b)

In the case of every successive member who receives instructions after the granting of judgment, instruction charges of -

- (i) (R20) R50 for claims of R1 up to R1500.
- (ii) (R40) R150 for claims over R1500.

Rule 81.1.1.1.(c)

- (12) R25 for every necessary letter or telegramme written or received and for each necessary attendance.

Rule 81.1.1.1.(d).

(R20) R45 for every 10 minutes or part thereof of every necessary consultation with a debtor.

Rule 81.1.1.2.

Collection commission at the rate of 10% on the amount collected, subject to a recommended maximum amount of **(R250) R350** for each payment or instalment, provided that where the member recovers commission from the debtor, either in terms of any law or in terms of contractual obligation, he shall credit his client therewith to the extent of, but not exceeding the collection commission debited to his client.

Collection commission covers all attendances and work done in connection with the receipt of a payment and accounting to a client in respect of a payment.
