### NATIONAL PROSECUTING AUTHORITY ACT, 1998 (ACT NO. 32 OF 1998)

#### REGULATIONS

The Minister for Justice and Constitutional Development has, under section 40 of the National Prosecuting Authority Act, 1998 (Act No. 32 of 1998), made the regulations in the Schedule.

#### SCHEDULE

##### Definitions

1. In these regulations any expression to which a meaning has been assigned in the Act shall bear that meaning and, unless the context otherwise indicates—

“the Act” means the National Prosecuting Authority Act, 1998 (Act No. 32 of 1998).

**Identity document for special investigators**

2. The identity document for a special investigator contemplated in section 19A(2) of the Act must be in the form which corresponds substantially with Form A in the Annexure.

**Conditions of service of special investigators**

3. Subject to the provisions of Chapter 3A of the Act, all conditions of service of special investigators are governed and regulated by the provisions of the Public Service Act, 1994(Proclamation 103 of 1994).

**Short title and commencement**

3. These regulations shall be called the Regulations for Conditions of Service of Special Investigators in the Directorate of Special Operations, 2001, and shall come into operation on 2 February 2001.

**REGULASIES**

Die Minister vir Justisie en Staatkundige Ontwikkeling het kragtens artikel 40 van die Wet op die Nasionale Vervolgingsgesag, 1998(Wet No. 32 van 1998), die regulasies in die Bylae uitgevaardig.

**BYLAE**

**Woordomskrywing**

1. In hierdie regulasies het 'n uitdrukking waaraan 'n betekenis in die Wet geheg is, die betekenis aldus daaraan geheg en, tensy uit die samehang anders blyk, beteken—

“die Wet” die Wet op die Nasionale Vervolgingsgesag, 1998(Wet No. 32 van 1998).

**Identiteitsdokument vir spesiale ondersoekers**

2. Die identiteitsdokument vir 'n spesiale ondersoeker beoog in artikel 19A(2)

van die Wet, moet in die vorm wees wat wesenlik ooreenstem met Vorm A in die Aanhangsel.

### **Diensvoorwaardes van spesiale ondersoekers**

3. Behoudens die bepalings van Hoofstuk 3A van die Wet, word alle diensvoorwaardes van spesiale ondersoekers deur die bepalings van die Staatsdienswet, 1994(Proklamasie 103 van 1994), beheer en gereël.

### **Kort titel en inwerkingtreding**

4. Hierdie regulasies heet die Regulasies vir die Diensvoorwaardes van Spesiale Ondersoekers in die Direktoraat Spesiale Operasies, 2001, en tree in werking op 2 Februarie 2001.
