I, Hendrik Christiaan Slabbert, Registrar of Labour Relations, hereby, in terms of section 106(2B) give notice of my intention to cancel the registration of the **Border Furniture Manufacturers' Association** for the following reason(s):

- The organisation has ceased to function as a genuine organisation as envisaged by section 106(2A)(a) the Act
- The organisation did not comply with the provisions of section 98, 99 and 100 of the Act [Section 106(2A)(b)]
