#### APPLICATION FOR THE AMENDMENT OF LICENCE CONDITIONS: PRIMEDIA BROADCASTING (PTY) LTD IN RESPECT OF RADIO 702

1. The Independent Communications Authority of South Africa (ICASA) wishes to amend **Government Gazette number 27724, Notice number 998 of 24 June 2005**, which notified the public of an application by Primedia Broadcasting in terms of section 52(1) (C) of the Independent Broadcasting Authority Act 153 of 1993 ("the Act") to amend its licence conditions by increasing its coverage area.
2. The amendment to the abovementioned notice is as a result of amendments submitted by Primedia Broadcasting (Pty) Ltd in respect of Radio 702 to their original application. The new amendment proposals are set out in the schedule below.
3. The proposed amendments are available at the Authority's library for inspection by any interested parties during the Authority's normal office hours.
4. Interested persons are hereby invited to make written representations on the proposed amendment to the Authority by **29 July 2005**. Interested persons who make such written representations to the Authority must simultaneously indicate whether they require an opportunity to make oral representations to the Authority on the proposed amendments.

7. Primedia Broadcasting (Pty) Ltd shall be entitled to respond in writing to the written representations made by interested persons on the proposed amendments, and any such written response must be submitted to the Authority

within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Radio 702 must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.
