### **PUBLICATION OF EXPLANATORY SUMMARY OF THE STATE ATTORNEY AMENDMENT BILL, 2013**

The Minister of Justice and Constitutional Development intends introducing the State Attorney Amendment Bill, 2013, in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The Bill is intended to amend the State Attorney Act, 1957 (Act No. 56 of 1957), so as to provide for the following:

- The establishment of offices of State Attorney;
- the appointment of a Solicitor-General and State Attorneys;
- the powers of the Minister relating to the functions of the offices of State Attorney;
- the powers and functions of the Solicitor-General; and
- matters connected therewith.

Die Wetsontwerp het ten doel om die Wet op die Staatsprokureur, 1957 (Wet No. 56 van 1957), te wysig ten einde vir die volgende voorsiening te maak:

- Die instelling van Staatsprokureurskantore;
- die aanstelling van 'n Prokureur-generaal en Staatsprokureurs;
- die bevoegdheids van die Minister met betrekking tot die werksaamhede van die Staatsprokureurskantore;
- die bevoegdheids en werksaamhede van die Prokureur-generaal; en
- aangeleenthede wat daarmee in verband staan.
