PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN

1. I, Ms. Tina Joemat-Pettersson, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 04 March 2015 to 31 March 2015 will be 931.0 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 04 March 2015**
