**MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): APPOINTMENT OF ONE OR MORE PLACES WITHIN EACH DISTRICT FOR THE HOLDING OF A COURT FOR SUCH DISTRICT**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1)(h) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby with effect from 1 February 2018 –

- (a) Appoint the Strand Concourse (Golden Acre complex), Erf 177689, Cnr of Strand and Adderley Streets, Cape Town, as a place for the holding of a court for the magisterial district of The Cape; and
- (b) Prescribe the local limits of the district of The Cape as the local limits within which the said court shall have jurisdiction.
