MAGISTRATES' COURTS ACT 1944 (ACT NO. 32 OF 1944): APPOINTMENT OF RITCHIE AS A PLACE FOR THE HOLDING OF A PERIODICAL COURT WITHIN THE MAGISTERIAL DISTRICT OF FRANCIS BAARD

I, Ronald Lamola, Minister of Justice and Correctional Services, acting under section 2(1) (j) and (l) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby with effect from 03 February 2020 –

- (a) Vary Notice No. 409 published in the Government Gazette No. 41552 of 29 March 2018, by the deletion of Modder River under Column "G" of the Schedule to the said notice;
- (b) Appoint Ritchie located at Erf 12, Main Road, Motswedimosa, a place for the holding of a periodical court within the Francis Baard Magisterial District; and
- (c) Prescribe the local limits of the district of Francis Baard as the local limits within which the said court shall have jurisdiction.
