
**REGULATIONS****FIREARMS CONTROL ACT, 2000 (ACT NO. 60 OF 2000)  
FIREARMS CONTROL AMENDMENT REGULATIONS, 2020**

The Minister of Police has, under section 145(1) of the Firearms Control Act, 2000 (Act No. 60 of 2000) amended regulation 79 of the Firearms Control Regulations, 2004, as set out in the Schedule.

**SCHEDULE****1. Definition**

In these regulations "the Regulations" mean the Firearms Control Regulations, 2004, promulgated in Government Notice No. R. 345, dated 26 March 2004 (as amended).

**2. Amendment of Regulation 79 of the Regulations**

(1) Regulation 79 of the Regulations is hereby amended by substitution for subparagraph (i) of subregulation (2)(b) with the following subregulation:

“(i) subject to subregulation (3), ensure that he or she undergo at least one practical training session at least every 12 months or within a shorter period as may be reasonably necessary in the circumstances, in the proper and safe handling and use of the relevant firearm and ammunition; and”.

(2) Regulation 79 of the Regulations is hereby amended by the insertion after subregulation (2) of the following subregulation:

“(3) In order to sustain the competency of an employee of an Official Institution contemplated in section 95(a)(ii) of the Act to whom a firearm was issued or may be issued, the head of that Official Institution must ensure that an employee of that Official Institution undergo at least one practical training session at least every 60 months or within such a shorter period as the Head of that Official Institution may from time to time direct, in the proper and safe handling and use of the relevant firearm and ammunition.”.

### **3. Short title and commencement**

These Regulations are called the Firearms Control Amendment Regulations, 2020, and shall come into operation on the date of publication.



**WET OP DIE BEHEER VAN VUURWAPENS, 2000 (WET NO. 60 VAN 2000)  
WYSIGINGSREGULASIES OP DIE BEHEER VAN VUURWAPENS, 2020**

Die Minister van Polisie het, ingevolge artikel 145(1) van die Wet op die Beheer van Vuurwapens, 2000 (Wet No. 60 van 2000), die wysiging van regulasie 79 van die Regulasies op die Beheer van Vuurwapens, 2004, soos vervat in die Bylaag uitgevaardig.

**BYLAAG****1. Woordomskrywings**

In hierdie Regulasies beteken "die Regulasies" die Regulasies op die Beheer van Vuurwapens, 2004, uitgevaardig deur Goewermentskennisgewing R. 345, gedateer 26 Maart 2004, soos gewysig.

**2. Wysiging van Regulasie 79 van die Regulasies**

- (1) Regulasie 79 van die Regulasies word hiermee gewysig deur die vervanging van subparagraaf (1) van regulasie 79(2)(b) met die volgende subparagraaf:

“Onderhewig aan sub-regulasie (3), seker maak dat hy of sy minstens een keer elke twaalf maande of met korter tussenposes indien dit redelikerwys nodig is onder die omstandighede, praktiese opleiding ondergaan in die behoorlike en veilige hantering van die betrokke vuurwapen en ammunisie; en”

- (2) Regulasie 79 van die Regulasies word hiermee gewysig deur die invoeging van die volgende subparagraaf na subparagraaf (2) daarvan:

“(3) Om die bevoegdheid van die werknemer van 'n amptelike instansie, beoog in artikel 95(a)(ii) van die Wet, aan wie 'n vuurwapen uitgereik is of mag uitgereik word, vol te hou moet die hoof van daardie amptelike instansie seker maak dat hy of sy minstens een keer elke sestig maande of met korter tussenposes indien dit redelikerwys nodig is onder die omstandighede, praktiese opleiding ondergaan in die behoorlike en veilige hantering van die betrokke vuurwapen en ammunisie

### **3. Kort titel en aanvang**

Die regulasies sal bekend wees as die Wysigingsregulasies op die Beheer van Vuurwapens, 2020, en word van krag by publikasie.
