

MAGISTRATES' COURTS ACT, 1944**APPOINTMENT OF PLACES WITHIN EACH REGIONAL DIVISION FOR THE
HOLDING OF A COURT FOR THE ADJUDICATION OF CERTAIN CIVIL DISPUTES
AND MAGISTERIAL DISTRICTS, SUB-DISTRICTS AND AREAS IN RESPECT
WHICH SUCH SHALL EXERCISE JURISDICTION**

1. I, Ronald Ozzy Lamola, Minister of Justice and Correctional Services, acting under sections 2(1)(b), 2(1)(d), 2(1)(eA), 2(1)(g)(ii), 2(1)(iA), 2(1)(l), 29(1) and 29(1B) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) (the Act), hereby—
- (a) establish a court for each regional division for the purposes of adjudicating civil disputes contemplated in section 29(1) and 29(1B) of the Act;
 - (b) appoint, within each regional division mentioned in Column A of the Schedule hereto, places listed under Column C of the Schedule for the holding of a court for the adjudication of civil disputes contemplated in section 29(1) or section 29(1B) or sections 29(1) and 29(1B) of the Act;
 - (c) prescribe, in Column D of the Schedule hereto, the local limits within which the court sitting at the place in Column C shall have jurisdiction;
 - (d) withdraw Government Notice No. 670 of 29 July 2010, as amended by Government Notices Nos. 615 of 3 August 2012, 216 of 27 March 2014, 857 of 31 October 2014, 964 of 28 November 2014, 3 of 18 January 2016 and 143 of 3 February 2016; and

- (e) determine 1 December 2020, as the date on which this Notice comes into operation.
2. Despite the withdrawal of Government Notice No. 670 of 29 July 2010—
- (a) proceedings which have already started but have not been concluded on the date referred to in paragraph 1(e) of this Notice may be proceeded with and concluded as if this Notice has not been published; and
 - (b) Government Notices No. 216 and 217 of 27 March 2014 are not withdrawn by this Notice.
