PROCLAMATION NOTICE 60 OF 2022

SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): APPOINTMENT OF TRIBUNAL PRESIDENT AND ADDITIONAL MEMBERS OF THE SPECIAL TRIBUNAL

I hereby, under section 7(1), (2) and (3)(4) and (5) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), after consultation with the Chief Justice of the Republic of South Africa and with effect from 1 May 2022: –

- (a) appoint Madam Judge Lebogang Modiba, a Judge of the Gauteng Division of the High Court, as Tribunal President of the Special Tribunal established by Proclamation No. R. 118 of 31 July 2001; and
- (b) appoint the following Judges as additional members of the Special Tribunal concerned:
 - (i) Madam Judge Soma Naidoo, a Judge of the Free State Division of the High Court; and
 - (ii) Mr Judge Johannes Daffue, a Judge of the Free State Division of the High Court.
