**BOARD NOTICE 644 OF 2024****CORRECTION NOTICE**

The South African Pharmacy Council hereby repeals Board Notice 643/2024, published on 2 August 2024 in Government Gazette 51005, and replaces it herewith.

**FEES PAYABLE TO THE COUNCIL UNDER THE PHARMACY ACT 53 OF 1974**

In terms of Regulation 3(2) of the *Regulations relating to the fees payable to Council* (GNR. 2827, published on 2 December 2022), Council may increase fees payable by way of a Board Notice and must publish a Board Notice on its website inviting comments or inputs on the proposed fee increment for a period of not less than thirty (30) days prior to the implementation of the increased increment. As in the past, all efforts will be made to curtail costs and keep any increases in fees to the minimum. The proposed fee increment for the year 2025 is hereby published for comments.

Interested persons are invited to submit within thirty (30) days of publication of this notice, substantiated comments or representations on the proposed fees payable to Council for 2025, to the Registrar, the South African Pharmacy Council by email to: [BN@sapc.za.org](mailto:BN@sapc.za.org) (for the attention of the Company Secretary and Legal Services).

**SCHEDULE**

In terms of Regulation 3(2) of the *Regulations relating to the fees payable to Council*, the proposed annual fee increment for the fees payable to the South African Pharmacy Council for 2025 shall be based on the headline consumer inflation rate for the month of October 2024.
