Tender TB/CE/001/09—For the Construction of Matumbo Bridge over the Luangwa River and access Roads in Eastern Province—Road Development Agency

THE Government of Zambia, acting through the Road Development Agency, is desirous to establish a road link between the Eastern and Northern Provinces. The construction of the Matumbo Bridge over the Luangwa River will help make this possible. In addition access roads will have to be opened up leading to the Bridge from the towns of Chama in the Eastern Province and Matumbo in the Northern Province. The Road Development Agency intends to apply some of the funds under Road Fund from the 2009 Annual Work Plan to cover eligible payments under the contract for the construction of Matumbo Bridge.

The Zambia Public Procurement Authority, on behalf of the Road Development Agency, now invites sealed bids from eligible and qualified bidders for these works. The tender is open to firms that are registered in Zambia as contractors of road works with the National Council for Construction in Category R, Grades 1, 2 and 3 and in possesion of a Valid Tax Clearance Certificate proof of which must be shown. Bidding will be conducted through the National Competitive Bidding proceedures. A preference factor of 7.5 percent will be applied for eligible domestic firms.

The scope of works includes, but not limited to the following:

- --- construction of a modular bridge spanning 120 m. This will be a three span bridge and will consist of two piers (11m high) and two abutments (8m high). These structures will be supported on piles (eight piles per pier and four on each abutment).
- formation of 160km access roads to the bridge being a single 150mm thick pavement layer of 5.5m wide carriageway with associated drainage structures such as culvets and mitre drains.
