THE Rural Electrification Authority (REA) has received funds from the Ministry of Finance and National Planning through budgetary allocations for the implementation of rural electrification projects that have been approved for 2009. It is intended that part of these funds will cover eligible payments under the contract for the Electrification of Kasaba Bay and Surrounding Areas in Mpulungu District, Northern Province.
